## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 803Q. (1) A PERSON WHO IS DESIGNATED AN HONORARY
- 2 CONSUL BY A DIPLOMATIC CORPS OF A NATION OTHER THAN THE UNITED
- 3 STATES THAT IS RECOGNIZED BY THE GOVERNMENT OF THE UNITED STATES
- 4 AND WHO IS ASSIGNED OR STATIONED IN MICHIGAN MAY MAKE APPLICATION
- 5 TO THE SECRETARY OF STATE FOR A SPECIAL REGISTRATION PLATE. THE
- 6 SPECIAL REGISTRATION PLATE SHALL HAVE THE WORDS "HONORARY CONSUL"
- 7 INSCRIBED BENEATH THE REGISTRATION LETTERS AND NUMBERS.
- 8 (2) APPLICATION FOR THE SPECIAL REGISTRATION PLATE DESCRIBED
- 9 IN SUBSECTION (1) SHALL BE ON A FORM PRESCRIBED BY THE SECRETARY
- 10 OF STATE, AND SHALL BE ACCOMPANIED BY ANY PROOF OF THE APPLICANT
- 11 BEING AN INDIVIDUAL WHO IS EMPLOYED IN A FOREIGN CONSULATE THAT

- 1 IS LOCATED IN MICHIGAN THAT THE SECRETARY OF STATE REQUIRES. THE
- 2 APPLICATION FOR THE SPECIAL REGISTRATION PLATE SHALL ALSO BE
- 3 ACCOMPANIED BY PAYMENT OF A \$30.00 CONSULATE IDENTIFICATION FEE
- 4 FOR 1 SPECIAL REGISTRATION PLATE OR A \$35.00 CONSULATE IDENTIFI-
- 5 CATION FEE FOR 2 OR MORE SPECIAL REGISTRATION PLATES AND A \$5.00
- 6 SERVICE FEE.
- 7 (3) UPON PROPER APPLICATION AND PAYMENT OF THE APPROPRIATE
- 8 CONSULATE IDENTIFICATION FEE AND THE \$5.00 SERVICE FEE REQUIRED
- 9 UNDER SUBSECTION (2), THE SECRETARY OF STATE SHALL ISSUE 1 OR
- 10 MORE SPECIAL REGISTRATION PLATES DESCRIBED IN SUBSECTION (1) FOR
- 11 EACH APPLICANT FOR USE ON A PASSENGER VEHICLE. A PERSON ISSUED 1
- 12 OR MORE SPECIAL REGISTRATION PLATES UNDER THIS SECTION SHALL BE

- 14 (4) THE USE OF A SPECIAL REGISTRATION PLATE DESCRIBED IN
- 15 SUBSECTION (1) ON A VEHICLE OTHER THAN THE VEHICLE FOR WHICH THE
- 16 PLATE IS ISSUED, OR BY A PERSON WHO DOES NOT QUALIFY UNDER THIS
- 17 SECTION, IS A MISDEMEANOR.
- 18 (5) THE SPECIAL REGISTRATION PLATE ISSUED UNDER THIS SECTION
- 19 SHALL EXPIRE ON THE BIRTHDAY OF THE VEHICLE OWNER. WHEN NEW
- 20 PLATES ARE ISSUED BY THE SECRETARY OF STATE, THE APPLICATION FOR
- 21 RENEWAL OF THE SPECIAL REGISTRATION PLATE SHALL BE ACCOMPANIED BY
- 22 A \$30.00 CONSULATE IDENTIFICATION FEE FOR 1 SPECIAL REGISTRATION
- 23 PLATE OR A \$35.00 CONSULATE IDENTIFICATION FEE FOR 2 OR MORE SPE-
- 24 CIAL REGISTRATION PLATES AND A \$5.00 SERVICE FEE. HOWEVER, THE
- 25 APPLICANT SHALL NOT BE REQUIRED TO FURNISH THE PROOF PROVIDED IN
- 26 SUBSECTION (2).

- 1 (6) THE ISSUANCE OF A SPECIAL REGISTRATION PLATE TO AN
- 2 APPLICANT UNDER THIS SECTION DOES NOT CONFER DIPLOMATIC STATUS OR
- 3 DIPLOMATIC IMMUNITY UPON THE APPLICANT.
