HOUSE BILL No. 4469

April 14, 1999, Introduced by Reps. DeHart and Schermesser and referred to the Committee on Family and Civil Law.

A bill to amend 1964 PA 170, entitled

"An act to make uniform the liability of municipal corporations, political subdivisions, and the state, its agencies and departments, officers, employees, and volunteers thereof, and members of certain boards, councils, and task forces when engaged in the exercise or discharge of a governmental function, for injuries to property and persons; to define and limit this liability; to define and limit the liability of the state when engaged in a proprietary function; to authorize the purchase of liability insurance to protect against loss arising out of this liability; to provide for defending certain claims made against public officers and paying damages sought or awarded against them; to provide for the legal defense of public officers and employees; to provide for reimbursement of public officers and employees for certain legal expenses; and to repeal certain acts and parts of acts,"

by amending section 1 (MCL 691.1401), as amended by 1986 PA 175, and by adding section 7a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 5 VOLUNTEER WHILE ACTING ON BEHALF OF THE MUNICIPAL CORPORATION.
- 6 (B) THE OFFICER, EMPLOYEE, MEMBER, OR VOLUNTEER IS ACTING OR
- 7 REASONABLY BELIEVES HE OR SHE IS ACTING WITHIN THE SCOPE OF HIS
- 8 OR HER AUTHORITY.
- 9 (C) THE MUNICIPAL CORPORATION IS ENGAGED IN THE EXERCISE OR
- 10 DISCHARGE OF A GOVERNMENTAL FUNCTION.
- 11 (D) THE OFFICER'S, EMPLOYEE'S, MEMBER'S, OR VOLUNTEER'S CON-
- 12 DUCT DOES NOT AMOUNT TO GROSS NEGLIGENCE THAT IS THE PROXIMATE
- 13 CAUSE OF THE INJURY OR DAMAGE. AS USED IN THIS SUBDIVISION,
- 14 "GROSS NEGLIGENCE" MEANS CONDUCT SO RECKLESS AS TO DEMONSTRATE A
- 15 SUBSTANTIAL LACK OF CONCERN FOR WHETHER AN INJURY OR SUBSTANTIAL
- 16 DAMAGE RESULTS.
- 17 (3) THIS SECTION DOES NOT GRANT IMMUNITY TO A MUNICIPAL COR-
- 18 PORATION OR AN EMPLOYEE OR AGENT OF A MUNICIPAL CORPORATION WITH
- 19 RESPECT TO PROVIDING MEDICAL CARE OR TREATMENT TO A PATIENT,
- 20 EXCEPT MEDICAL CARE OR TREATMENT PROVIDED TO A PATIENT IN A HOS-
- 21 PITAL OWNED OR OPERATED BY THE DEPARTMENT OF COMMUNITY HEALTH OR
- 22 A HOSPITAL OWNED OR OPERATED BY THE DEPARTMENT OF CORRECTIONS.
- 23 (4) THIS SECTION SHALL NOT BE CONSTRUED AS MODIFYING OR
- 24 RESTRICTING THE IMMUNITY OF A GOVERNMENTAL AGENCY OTHERWISE PRO-
- 25 VIDED IN THIS ACT. THIS SECTION DOES NOT LIMIT THE ABILITY OF A
- 26 MUNICIPAL CORPORATION TO ENTER INTO AN AGREEMENT THAT WAIVES OR
- 27 LIMITS ITS IMMUNITY DESCRIBED IN SUBSECTION (1) AND CONTAINS

- 1 PROVISIONS IT FINDS APPROPRIATE ON THE ISSUE OF ITS LIABILITY,
- 2 DAMAGES, OR BOTH FOR COMPUTER DATE FAILURE.
