THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 20104. (1) "Certification" means the issuance of a
- 2 document by the department to a health facility or agency attest-

- 5 (a) It complies COMPLIES with applicable statutory, ADMIN-

- 24 R 325.3866, R 325.3867, AND R 325.3868 OF THE MICHIGAN ADMINIS-
- 25 TRATIVE CODE, BUT SHALL INCLUDE IN THE RULES STANDARDS FOR FREE-
- 26 STANDING SURGICAL OUTPATIENT FACILITIES IN WHICH MORE THAN 50
- 27 ABORTIONS PER CALENDAR YEAR ARE PERFORMED. THE DEPARTMENT SHALL

- 1 ASSURE THAT THE STANDARDS ARE CONSISTENT WITH THE MOST RECENT
- 2 UNITED STATES SUPREME COURT DECISIONS REGARDING STATE REGULATION
- 3 OF ABORTIONS. AS USED IN THIS SUBSECTION, "ABORTION" MEANS THAT
- 4 TERM AS DEFINED IN SECTION 17015.
