- 6 REGISTRATION PLATE. MICHIGAN CARES REGISTRATION PLATES SHALL

- 10 (A) A SHELTER FOR HOMELESS PERSONS.

- 12 (C) A FOOD BANK.
- 13 (D) ANOTHER ENTITY LOCATED IN THIS STATE, THE PRIMARY PUR-
- 14 POSE OF WHICH IS TO PROVIDE OVERNIGHT ACCOMMODATION, FOOD, OR
- 15 MEALS TO PERSONS WHO ARE INDIGENT IF A CONTRIBUTION TO THAT
- 16 ENTITY WOULD BE TAX DEDUCTIBLE FOR A DONOR UNDER SECTION 261 OF
