THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 PART 465 FISHING SHANTIES ICE FISHING SHANTIES AND RESCUES
- 2 Sec. 46501. As used in this part:
- 3 (a) "Fishing shanty" means a fishing house or any other
- 4 structure or shelter placed on the ice on the waters over which
- 5 this state has jurisdiction.
- 6 (B) "FUND" MEANS THE ICE FISHING RESCUE FUND CREATED IN SEC-
- 7 TION 46510.
- 8 (C) (C) (b) "Local unit of government" means a county, city,
- 9 township, village, or other governmental unit. Local unit of
- 10 government does not include the state.

- 1 SEC. 46510. (1) THE ICE FISHING RESCUE FUND IS CREATED
