

HOUSE BILL No. 4857

September 28, 1999, Introduced by Reps. Basham, Bogardus, DeHart, Schermesser, Hale and Sanborn and referred to the Committee on Tax Policy.

A bill to amend 1967 PA 281, entitled "Income tax act of 1967,"

(MCL 206.1 to 206.532) by adding section 438.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 438. (1) FOR THE 2000 TAX YEAR AND EACH TAX YEAR AFTER
- 2 THE 2000 TAX YEAR, A TAXPAYER MAY DESIGNATE ON HIS OR HER ANNUAL
- 3 RETURN THAT A CONTRIBUTION OF \$2.00 OR MORE OF HIS OR HER REFUND
- 4 BE CREDITED TO THE GREAT LAKES ENDOWMENT FUND CREATED IN THE
- 5 GREAT LAKES ENDOWMENT FUND ACT. IF A TAXPAYER'S REFUND IS NOT
- 6 SUFFICIENT TO MAKE A CONTRIBUTION UNDER THIS SECTION, THE TAX-
- 7 PAYER MAY DESIGNATE A CONTRIBUTION AMOUNT AND THAT CONTRIBUTION
- 8 AMOUNT SHALL BE ADDED TO THE TAXPAYER'S TAX LIABILITY FOR THE TAX
- 9 YEAR.

- 1 (2) THE CONTRIBUTION DESIGNATION AUTHORIZED IN THIS SECTION
- 2 SHALL BE CLEARLY AND UNAMBIGUOUSLY PRINTED ON THE FIRST PAGE OF
- 3 ALL STATE INDIVIDUAL INCOME TAX RETURN FORMS, IF PRACTICABLE.
- 4 (3) NOTWITHSTANDING THE OTHER ALLOCATIONS AND DISBURSEMENTS
- 5 REQUIRED BY THIS ACT, AN AMOUNT EQUAL TO THE CUMULATIVE DESIGNA-
- 6 TIONS MADE UNDER THIS SECTION, LESS THE AMOUNT APPROPRIATED TO
- 7 THE DEPARTMENT OF TREASURY FOR THE PURPOSE OF IMPLEMENTING THIS
- 8 SECTION, SHALL BE DEPOSITED IN THE GREAT LAKES ENDOWMENT FUND AND
- 9 SHALL BE APPROPRIATED SOLELY FOR THE PURPOSES OF THE GREAT LAKES
- 10 ENDOWMENT FUND AS SPECIFIED IN THE GREAT LAKES ENDOWMENT FUND
- **11** ACT.
- 12 Enacting section 1. This amendatory act does not take
- 13 effect unless Senate Bill No. _____ or House Bill No. 4858
- 14 (request no. 03513'99 a) of the 90th Legislature is enacted into
