Rocca, Sheltrown, Spade, Howell, Jamnick, Faunce, Jelinek, Bogardus, Bovin, Wojno, Jansen, Garza, Gosselin, Richardville, Garcia, Law, Mortimer, Ehardt, Dennis, Richner, Lockwood, Clarke, DeHart and Raczkowski and referred to the Committee on Veterans Affairs.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 811d.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 811D. (1) THE SECRETARY OF STATE SHALL DEVELOP AND,
- 2 UPON APPLICATION, MAY ISSUE A MICHIGAN VETERANS MEMORIAL REGIS-
- 3 TRATION PLATE TO AN APPLICANT FOR USE ON THE PASSENGER MOTOR
- 4 VEHICLE, PICKUP TRUCK, VAN, MOTOR HOME, HEARSE, BUS, TRAILER
- 5 COACH, OR TRAILER FOR WHICH THE REGISTRATION PLATE IS ISSUED
- 6 INSTEAD OF A STANDARD REGISTRATION PLATE. MICHIGAN VETERANS
- 7 MEMORIAL REGISTRATION PLATES SHALL BEAR LETTERS AND NUMBERS THAT
- 8 THE SECRETARY OF STATE PRESCRIBES. THE PLATE SHALL BE OF A
- 9 DESIGN AS DETERMINED BY THE SECRETARY OF STATE. THE WORD
- 10 "MICHIGAN" SHALL APPEAR ON EACH MICHIGAN VETERANS MEMORIAL
- 11 REGISTRATION PLATE.

- 1 (2) AN APPLICATION FOR A MICHIGAN VETERANS MEMORIAL
- 2 REGISTRATION PLATE SHALL BE SUBMITTED TO THE SECRETARY OF STATE
- 3 PURSUANT TO THE PROCEDURES PRESCRIBED IN SECTION 217.
- 4 APPLICATION FOR AN ORIGINAL OR RENEWAL MICHIGAN VETERANS MEMORIAL
- 5 REGISTRATION PLATE SHALL BE ACCOMPANIED WITH PAYMENT OF THE REGU-
- 6 LAR VEHICLE REGISTRATION TAX IN ADDITION TO A SERVICE FEE AS
- 7 FOLLOWS:
- 8 (A) FOR AN ORIGINAL MICHIGAN VETERANS MEMORIAL REGISTRATION
- 9 PLATE, \$3.00 FOR THE FIRST MONTH AND \$2.00 PER MONTH FOR EACH
- 10 ADDITIONAL MONTH OF THE REGISTRATION PERIOD.
- 11 (B) FOR A RENEWAL MICHIGAN VETERANS MEMORIAL REGISTRATION
- **12** PLATE, \$10.00.
- 13 (3) A MICHIGAN VETERANS MEMORIAL REGISTRATION PLATE SHALL
- 14 EXPIRE AS DESCRIBED IN SECTION 226. UPON THE ISSUANCE OR RENEWAL
- 15 OF A MICHIGAN VETERANS MEMORIAL REGISTRATION PLATE, THE SECRETARY
- 16 OF STATE MAY ISSUE A TAB OR TABS DESIGNATING THE MONTH AND YEAR
- 17 OF EXPIRATION.
- 18 (4) THE SECRETARY OF STATE MAY ISSUE A TEMPORARY REGISTRA-
- 19 TION PERMIT TO A PERSON WHO SUBMITS AN APPLICATION AND THE PROPER
- 20 PAYMENTS FOR A MICHIGAN VETERANS MEMORIAL REGISTRATION PLATE IF
- 21 THE APPLICANT'S CURRENT VEHICLE REGISTRATION WILL EXPIRE BEFORE
- 22 HIS OR HER RECEIPT OF A MICHIGAN VETERANS MEMORIAL REGISTRATION
- 23 PLATE. THE TEMPORARY REGISTRATION SHALL EXPIRE UPON RECEIPT OF A
- 24 MICHIGAN VETERANS MEMORIAL REGISTRATION PLATE OR 60 DAYS AFTER
- 25 THE ISSUANCE OF A MICHIGAN VETERANS MEMORIAL REGISTRATION PLATE,
- 26 WHICHEVER OCCURS FIRST. THE TEMPORARY PERMIT SHALL BE ISSUED
- 27 WITHOUT A SEPARATE FEE.

- 1 (5) MICHIGAN VETERANS MEMORIAL REGISTRATION PLATE SERVICE
- 2 FEES COLLECTED UNDER THIS SECTION BY THE SECRETARY OF STATE SHALL
- 3 BE IDENTIFIED AND SEGREGATED BY THE SECRETARY OF STATE INTO A
- 4 SEPARATE ACCOUNT. AFTER DEDUCTING THE MANUFACTURING AND ADMINIS-
- 5 TRATIVE COSTS OF THE SECRETARY OF STATE, INCLUDING ADMINISTRATIVE
- 6 COSTS ASSOCIATED WITH ISSUING, REPLACING, AND SUBSTITUTING
- 7 PLATES, THE SECRETARY OF STATE SHALL ON A QUARTERLY BASIS TRANS-
- 8 FER THE BALANCE OF THE MICHIGAN VETERANS MEMORIAL REGISTRATION
- 9 PLATE SERVICE FEES TO THE STATE TREASURER WHO SHALL CREDIT THE
- 10 FEE MONEY TO THE VIETNAM VETERANS MEMORIAL MONUMENT FUND CREATED
- 11 IN SECTION 3 OF THE MICHIGAN VIETNAM VETERANS MEMORIAL ACT, 1988
- 12 PA 234, MCL 35.1053. THESE FUNDS SHALL BE USED EXCLUSIVELY FOR
- 13 THE PURPOSES DESCRIBED IN SECTIONS 5 AND 7 OF THE MICHIGAN
- 14 VIETNAM VETERANS MEMORIAL ACT, 1988 PA 234, MCL 35.1055 AND
- **15** 35.1057.
- 16 (6) FOR PURPOSES OF THIS SECTION, "MICHIGAN VETERANS MEMO-
- 17 RIAL REGISTRATION PLATE" MEANS A REGISTRATION PLATE CONTAINING A
- 18 SPECIALIZED DESIGN PERTAINING TO MICHIGAN VETERANS.
