- 25 (E) "COMPUTER SOFTWARE" MEANS A SET OF COMPUTER PROGRAMS,
- 26 PROCEDURES, AND ASSOCIATED DOCUMENTATION RELATED TO THE OPERATION
- 27 OF A COMPUTER, COMPUTER SYSTEM, OR COMPUTER NETWORK.

- 1 (F) "COMPUTER SYSTEM" MEANS A COMBINATION OF A COMPUTER OR A
- 2 COMPUTER NETWORK WITH THE DOCUMENTATION, COMPUTER SOFTWARE, OR
- 3 PHYSICAL FACILITIES SUPPORTING THE COMPUTER OR COMPUTER NETWORK.
- 4 (G) "EMBEDDED CHIP" MEANS A SINGLE OR MULTIPLE MICROPROCES-
- 5 SOR CHIP THAT OPERATES IN CONJUNCTION WITH SOFTWARE, INCLUDING
- 6 SOFTWARE ON THE CHIP ITSELF, THAT IN SOME WAY CONTROLS A DEVICE
- 7 OR EQUIPMENT, INCLUDING, BUT NOT LIMITED TO, A COMPUTER OR OTHER
- 8 ELECTRONIC OR MECHANICAL DEVICE.
- 9 (H) "STATE AGENCY" MEANS A DEPARTMENT, BOARD, COMMISSION,
- 10 OFFICE, AGENCY, AUTHORITY, OR OTHER UNIT OF STATE GOVERNMENT.
- 11 STATE AGENCY DOES NOT INCLUDE AN INSTITUTION OF HIGHER EDUCATION
