A bill to amend 1949 PA 300, entitled
"Michigan vehicle code,"
(MCL 257.1 to 257.923) by adding section 811n.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 811N. (1) THE SECRETARY OF STATE SHALL DEVELOP UNDER
2 SECTION 811E AND, UPON APPLICATION, MAY ISSUE UNDER SECTION 811F
3 A STATE-SPONSORED AGRICULTURAL HERITAGE FUND-RAISING REGISTRATION
4 PLATE AND A MATCHING STATE-SPONSORED AGRICULTURAL HERITAGE COL-
5 LECTOR PLATE AS PROVIDED UNDER SECTION 811G.
6 (2) AGRICULTURAL HERITAGE FUND-RAISING REGISTRATION PLATE
7 DONATIONS COLLECTED UNDER SECTION 811F AND MATCHING AGRICULTURAL
8 HERITAGE COLLECTOR PLATE FUND-RAISING DONATIONS COLLECTED UNDER
9 SECTION 811G SHALL BE TRANSFERRED UNDER SECTION 811H BY THE
10 SECRETARY OF STATE TO THE STATE TREASURER, WHO SHALL DISBURSE THE
11 DONATION MONEY TO THE MICHIGAN FUTURE FARMERS OF AMERICA

1 FOUNDATION ENDOWMENT FUND ADMINISTERED BY MICHIGAN STATE
2 UNIVERSITY FOR THE PURPOSE OF THE VISION2000 PUBLIC/PRIVATE
3 INITIATIVE.

4 (3) FOR PURPOSES OF THIS CHAPTER, "STATE-SPONSORED AGRICUL-
5 TURAL HERITAGE FUND-RAISING REGISTRATION PLATE" MEANS A REGISTRA-
6 TION PLATE CONTAINING A SPECIALIZED DESIGN PERTAINING TO THE
7 AGRICULTURE OF THIS STATE.

8 Enacting section 1. This amendatory act takes effect
9 October 1, 2000.

10 Enacting section 2. This amendatory act does not take
11 effect unless Senate Bill No. 826 or House Bill No. _____
12 (request no. 03790'99) of the 90th Legislature is enacted into
13 law.
