A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 811k.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 811K. (1) THE SECRETARY OF STATE SHALL DEVELOP UNDER
- 2 SECTION 811E AND, UPON APPLICATION, MAY ISSUE UNDER SECTION 811F
- 3 A STATE-SPONSORED LIGHTHOUSE FUND-RAISING REGISTRATION PLATE AND
- 4 A MATCHING STATE-SPONSORED LIGHTHOUSE FUND-RAISING COLLECTOR
- 5 PLATE AS PROVIDED UNDER SECTION 811G. THE PLATE SHALL BE OF A
- 6 DESIGN AS DETERMINED BY THE SECRETARY OF STATE.
- 7 (2) THE MICHIGAN LIGHTHOUSE PRESERVATION GRANT FUND IS CRE-
- 8 ATED AS A SEPARATE FUND IN THE DEPARTMENT OF TREASURY. THE FUND
- 9 SHALL BE EXPENDED ONLY AS PROVIDED IN THIS SECTION. THE STATE
- 10 TREASURER MAY RECEIVE MONEY OR OTHER ASSETS FROM ANY SOURCE FOR
- 11 DEPOSIT INTO THE FUND. THE STATE TREASURER SHALL DIRECT THE

- 1 INVESTMENT OF THE FUND. THE STATE TREASURER SHALL CREDIT TO THE
- 2 FUND INTEREST AND EARNINGS FROM FUND INVESTMENTS. THE STATE
- 3 TREASURER SHALL ANNUALLY PRESENT TO THE SECRETARY OF STATE AN
- 4 ACCOUNTING OF THE AMOUNT OF MONEY IN THE FUND. MONEY IN THE FUND
- 5 AT THE CLOSE OF THE FISCAL YEAR SHALL REMAIN IN THE FUND AND
- 6 SHALL NOT LAPSE TO THE GENERAL FUND.
- 7 (3) THE SECRETARY OF STATE SHALL ADMINISTER THE FUND AND MAY
- 8 EXPEND MONEY FROM THE FUND THROUGH DISCRETIONARY HISTORICAL
- 9 GRANTS TO PRESERVE MICHIGAN LIGHTHOUSES. THE SECRETARY OF STATE
- 10 SHALL NOT USE NOT MORE THAN 10% OF THE FUNDS FOR THE SECRETARY OF
- 11 STATE'S COSTS THAT OCCUR FROM FUND ADMINISTRATION AND GRANT
- 12 PROJECT COORDINATION.
- 13 (4) THE SECRETARY OF STATE MAY AWARD GRANTS FOR THE PREPARA-
- 14 TION OF PLANS AND SPECIFICATIONS FOR RESTORATION AND STABILIZA-
- 15 TION AND FOR STABILIZATION, REHABILITATION, OR OTHER PRESERVATION
- 16 WORK ON A MICHIGAN LIGHTHOUSE, BUT GRANTS SHALL NOT BE AWARDED
- 17 FOR OPERATIONAL PURPOSES. THE SECRETARY OF STATE SHALL ALLOCATE
- 18 GRANT FUNDS PURSUANT TO ELIGIBILITY AND SCORING REQUIREMENTS
- 19 ESTABLISHED BY THE SECRETARY OF STATE. TO AWARD GRANTS UNDER
- 20 THIS SECTION, THE SECRETARY OF STATE SHALL SOLICIT APPLICATIONS
- 21 FROM ELIGIBLE RECIPIENTS, SCORE APPLICATIONS BASED ON THE ESTAB-
- 22 LISHED CRITERIA, AND AWARD GRANTS THROUGH EXECUTED CONTRACTS.
- 23 ALL PLANS AND WORK PERFORMED UNDER A GRANT SHALL BE CONSISTENT
- 24 WITH THE UNITED STATES SECRETARY OF THE INTERIOR'S STANDARDS FOR
- 25 REHABILITATION AND GUIDELINES FOR REHABILITATING HISTORIC BUILD-
- 26 INGS, 36 C.F.R. 67, HISTORIC PRESERVATION CERTIFICATIONS.

- 1 (5) LIGHTHOUSE FUND-RAISING REGISTRATION PLATE DONATIONS
- 2 COLLECTED UNDER SECTION 811F AND MATCHING LIGHTHOUSE COLLECTOR
- 3 PLATE FUND-RAISING DONATIONS COLLECTED UNDER SECTION 811G SHALL
- 4 BE TRANSFERRED UNDER SECTION 811M BY THE SECRETARY OF STATE TO
- 5 THE STATE TREASURER, WHO SHALL CREDIT THE DONATION MONEY TO THE
- 6 MICHIGAN LIGHTHOUSE PRESERVATION GRANT FUND FOR THE PRESERVATION
- 7 OF HISTORIC MICHIGAN LIGHTHOUSES.
- **8** (6) FOR PURPOSES OF THIS CHAPTER, "STATE-SPONSORED LIGHT-
- 9 HOUSE FUND-RAISING REGISTRATION PLATE" MEANS A REGISTRATION PLATE
- 10 CONTAINING A SPECIALIZED DESIGN PERTAINING TO HISTORIC MICHIGAN
- 11 LIGHTHOUSES.
- 12 Enacting section 1. This amendatory act takes effect
- **13** October 1, 2000.
- 14 Enacting section 2. This amendatory act does not take
- 15 effect unless Senate Bill No. 826 or House Bill No. _____
- 16 (request no. 03790'99) of the 90th Legislature is enacted into
