

HOUSE BILL No. 5128

November 10, 1999, Introduced by Rep. Bradstreet and referred to the Committee on Constitutional Law and Ethics.

A bill to amend 1980 PA 299, entitled "Occupational code,"

(MCL 339.101 to 339.2721) by adding article 17A.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 2 SEC. 1760. (1) THE DEPARTMENT SHALL NOT ISSUE A LICENSE
- 3 UNLESS THE APPLICANT APPEARS PERSONALLY BEFORE THE DIRECTOR. THE
- 4 APPLICANT SHALL AFFIX THE APPLICANT'S ORIGINAL SIGNATURE AND
- 5 SOCIAL SECURITY NUMBER TO THE APPLICATION IN THE PRESENCE OF THE
- 6 DIRECTOR AND SHALL CERTIFY OR ACKNOWLEDGE UNDER OATH THAT THE
- 7 APPLICATION IS THE APPLICANT'S ACT AND DEED AND THAT THE FACTS
- 8 STATED IN THE APPLICATION ARE TRUE.
- 9 (2) IF THE APPLICANT IS A CORPORATION, SUBSECTION (1) IS
- 10 SATISFIED BY THE APPEARANCE, ORIGINAL SIGNATURE, SOCIAL SECURITY
- 11 NUMBER, AND CERTIFICATION OR ACKNOWLEDGMENT UNDER OATH OF A

- 12 SEC. 1761. (1) THE DEPARTMENT SHALL NOT ISSUE A LICENSE TO
- 13 ENGAGE IN THE OCCUPATION OF MASSAGIST TO ANY PERSON CONVICTED OF
- 14 A CRIME OR VIOLATION OF A LOCAL ORDINANCE INVOLVING LEWDNESS,
- 15 PROSTITUTION, PROMOTING PROSTITUTION, SEXUAL ASSAULT OR ASSAULT
- 16 WITH INTENT TO COMMIT CRIMINAL SEXUAL CONDUCT, SEXUAL MISCONDUCT,

- 21 (2) THE DEPARTMENT SHALL NOT ISSUE A LICENSE FOR THE OPERA-
- 22 TION OF A MASSAGE ESTABLISHMENT TO ANY OF THE FOLLOWING:
- 23 (A) A PERSON CONVICTED OF A CRIME OR VIOLATION OF A LOCAL
- 24 ORDINANCE INVOLVING LEWDNESS, PROSTITUTION, PROMOTING PROSTITU-
- 25 TION, SEXUAL ASSAULT OR ASSAULT WITH INTENT TO COMMIT CRIMINAL
- 26 SEXUAL CONDUCT, SEXUAL MISCONDUCT, INDECENT EXPOSURE, INCEST,
- 27 RAPE OR CRIMINAL SEXUAL CONDUCT, OR SODOMY, OR A PERSON

- 1 REGISTERED AS A SEX OFFENDER, IN THIS STATE OR ANY OTHER STATE OR
- 2 JURISDICTION WITHIN THE 3 YEARS PRIOR TO THE DATE OF
- 3 APPLICATION.
- 4 (B) A PERSON WHO HELD A LICENSE FOR THE OPERATION OF A MAS-
- 5 SAGE ESTABLISHMENT UNDER THIS ARTICLE THAT WAS REVOKED PURSUANT
- 6 TO SECTION 1762 WITHIN THE 2-YEAR PERIOD PRIOR TO THE DATE OF
- 7 APPLICATION.
- 8 (C) A PERSON WHO WAS AN OFFICER, DIRECTOR, OR PRINCIPAL
- 9 OWNER OF A CORPORATION, A MANAGER OR PRINCIPAL OWNER OF A LIMITED
- 10 LIABILITY COMPANY, OR A PARTNER OR MEMBER OF A PARTNERSHIP OR
- 11 OTHER UNINCORPORATED ASSOCIATION, THAT HELD A LICENSE FOR THE
- 12 OPERATION OF A MASSAGE ESTABLISHMENT THAT WAS REVOKED WITHIN THE
- 13 2-YEAR PERIOD PRIOR TO THE DATE OF APPLICATION PURSUANT TO SEC-
- 14 TION 1762 FOR AN OFFENSE OR VIOLATION COMMITTED BY ANYONE WHILE
- 15 THE PERSON SERVED IN THAT CAPACITY FOR THE CORPORATION, LIMITED
- 16 LIABILITY COMPANY, PARTNERSHIP, OR UNINCORPORATED ASSOCIATION.
- 17 (D) A PERSON WHOSE APPLICATION BEARS THE SIGNATURE OF A
- 18 PERSON DESCRIBED IN SUBDIVISION (A), (B), OR (C).
