



# HOUSE BILL No. 5184

December 9, 1999, Introduced by Reps. DeRossett, Howell, Jamnick and O'Neil and referred to the Committee on Criminal Law and Corrections.

A bill to amend 1927 PA 175, entitled  
"The code of criminal procedure,"  
(MCL 760.1 to 777.69) by adding section 18a to chapter XVII.
