

HOUSE BILL No. 5450

February 24, 2000, Introduced by Reps. Kukuk, DeWeese, LaSata, Cameron Brown, Voorhees, Gosselin, Rocca, Stamas, Kowall, Caul, DeRossett, Toy, Pappageorge, Cassis, Ruth Johnson, Richardville, Mortimer, Schermesser, Jansen, Birkholz and DeHart and referred to the Committee on Energy and Technology.

A bill to amend 1971 PA 227, entitled

"An act to prescribe the rights and duties of parties to home solicitation sales,"

(MCL 445.111 to 445.117) by adding section 10.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 10. (1) TELEPHONE SOLICITORS SHALL NOT USE TELEPHONE
- 2 EOUIPMENT OR TELECOMMUNICATIONS NETWORK ELEMENTS THAT BLOCK OR
- 3 OTHERWISE INTERFERE WITH THE CALLER ID FUNCTION ON THE TELEPHONE
- 4 OF A RESIDENTIAL TELEPHONE SUBSCRIBER TO WHOM A TELEPHONE SOLICI-
- 5 TATION IS MADE SO THAT THE TELEPHONE NUMBER OF THE CALLER IS NOT
- 6 DISPLAYED ON THE TELEPHONE EQUIPMENT OF THE CALLED PARTY.
- 7 (2) LOCAL EXCHANGE PROVIDERS AND INTEREXCHANGE TOLL PROVID-
- 8 ERS ARE PROHIBITED FROM PROVIDING ANY NETWORK ELEMENT OR SERVICE
- 9 TO TELEPHONE SOLICITORS THAT WOULD BLOCK OR OTHERWISE INTERFERE
- 10 WITH ON A PER LINE BASIS, THE DISPLAY OF THE TELEPHONE

- 1 SOLICITOR'S NAME AND TELEPHONE NUMBER ON THE RESIDENTIAL
- 2 SUBSCRIBER'S CALLER ID EQUIPMENT. LOCAL EXCHANGE PROVIDERS AND
- 3 INTEREXCHANGE PROVIDERS SHALL MODIFY THEIR TARIFFS TO REFLECT THE
- 4 REQUIREMENTS OF THIS ACT WITHIN 60 DAYS AFTER THE EFFECTIVE DATE
- 5 OF THE AMENDATORY ACT THAT ADDED THIS SECTION.
- 6 Enacting section 1. This amendatory act does not take
- 7 effect unless Senate Bill No. _____ or House Bill No. 5446
- 8 (request no. 06035'00) of the 90th Legislature is enacted into
- **9** law.
