

## **HOUSE BILL No. 5717**

May 2, 2000, Introduced by Reps. Schauer, Basham, Jamnick, Gieleghem, Dennis, Martinez, Hale, Pappageorge, Woodward and Jacobs and referred to the Committee on Criminal Law and Corrections.

A bill to amend 1985 PA 87, entitled

"Crime victim's rights act,"

(MCL 780.751 to 780.834) by adding sections 22b, 46b, and 80a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 22B. (1) UPON CONVICTION OF A DEFENDANT FOR A CRIME
- 2 INVOLVING DOMESTIC VIOLENCE, THE COURT SHALL INQUIRE OF THE
- 3 VICTIM OF THAT CRIME WHETHER HE OR SHE WOULD LIKE TO BE CERTIFIED
- 4 AS A VICTIM OF DOMESTIC VIOLENCE FOR PURPOSES OF SECTION 208E OF
- 5 THE MICHIGAN VEHICLE CODE, 1949 PA 300, MCL 257.208E. IF THE
- 6 INDIVIDUAL INFORMS THE COURT THAT HE OR SHE WOULD LIKE TO BE CER-
- 7 TIFIED AS A VICTIM OF DOMESTIC VIOLENCE, THE COURT SHALL PROMPTLY
- 8 MAKE THAT CERTIFICATION. THE CERTIFICATION SHALL BE ON A FORM
- 9 AND IN THE MANNER PRESCRIBED BY THE SECRETARY OF STATE. THE
- 10 COURT SHALL FORWARD THE CERTIFICATION TO THE SECRETARY OF STATE
- 11 WITHIN 7 DAYS AFTER THE CERTIFICATION IS MADE.
