

HOUSE BILL No. 5734

May 4, 2000, Introduced by Reps. Woronchak, Scranton, Julian and Bishop and referred to the Committee on Energy and Technology.

A bill to amend 1976 PA 331, entitled "Michigan consumer protection act,"

(MCL 445.901 to 445.922) by adding section 3e.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 3E. (1) ALL PROVIDERS OF PREPAID CALLING SERVICES
- 2 SHALL DISPLAY IN A CONSPICUOUS MANNER ON PREPAID CALLING CARDS
- 3 AND ON ANY ACCOMPANYING PACKAGING ALL OF THE FOLLOWING
- 4 INFORMATION:
- 5 (A) THE NAME OF THE PROVIDER OF THE PREPAID CALLING SERVICES
- 6 AS REGISTERED WITH THE COMMISSION UNDER SECTION 3F.
- 7 (B) THE ACTUAL TOTAL CHARGE PER MINUTE FOR THE FIRST MINUTE
- 8 AND FOR EACH ADDITIONAL MINUTE FOR THE PREPAID CALLING SERVICE.
- 9 THE QUOTED CHARGE SHALL INCLUDE ALL CALLING CHARGES, SURCHARGES,
- 10 FEES, AND TAXES. THE QUOTED CHARGE SHALL BE IN THE SAME SIZE

- 1 TYPE FACE AS ANY OTHER PER MINUTE RATE SHOWN ON THE CARD OR THE
- 2 PACKAGING OF THE CARD.
- 3 (C) A TOLL-FREE NETWORK ACCESS AND CUSTOMER SERVICE NUMBER
- 4 THAT THE END USER CAN CALL TO OBTAIN AN ACCOUNTING OF CARD USE AT
- 5 NO CHARGE TO THE END USER.
- 6 (D) INFORMATION ON HOW TO CONTACT THE COMMISSION.
- 7 (E) ANY EXPIRATION POLICY.
- 8 (2) ALL PROVIDERS OF PREPAID CALLING SERVICES SHALL REQUIRE
- 9 BY CONTRACT WITH RETAILERS AND DISTRIBUTORS THE REQUIREMENTS OF
- 10 THIS SECTION.
- 11 (3) ALL PROVIDERS OF PREPAID CALLING SERVICES SHALL, AT THE
- 12 BEGINNING OF EACH CALL MADE THROUGH THE ACCESS NUMBER, AND ON
- 13 REOUEST WHEN THE END USER PLACES A CALL TO THE PROVIDER'S CUS-
- 14 TOMER SERVICE NUMBER, ALL OF THE FOLLOWING INFORMATION:
- 15 (A) THAT A COMPLETE RATE QUOTE FOR THE CALL, INCLUDING ALL
- 16 SURCHARGES OR OTHER CHARGES, IS AVAILABLE AND HOW TO OBTAIN THE
- 17 COMPLETE RATE QUOTE WITHOUT HANGING UP THE TELEPHONE OR INCURRING
- 18 A CHARGE.
- 19 (B) A DISCLOSURE OF THE REMAINING BALANCE ON THE PREPAID
- 20 CALLING CARD.
- 21 (C) THE EXPIRATION DATE, IF ANY, OF THE PREPAID CALLING
- **22** CARD.
- 23 (D) THAT THERE WILL BE NO CHARGE FOR AN UNCOMPLETED CALL.
- 24 (4) AS USED IN THIS SECTION AND SECTION 3F:
- 25 (A) "COMMISSION" MEANS THE MICHIGAN PUBLIC SERVICE COMMIS-
- 26 SION IN THE DEPARTMENT OF CONSUMER AND INDUSTRY SERVICES.

- 1 (B) "PREPAID CALLING CARD" MEANS AN OBJECT CONTAINING AN
- 2 ACCESS NUMBER OR AUTHORIZATION CODE THAT ENABLES AN END USER TO
- 3 USE PREPAID CALLING SERVICES.
- 4 (C) "PREPAID CALLING SERVICES" MEANS A PREPAID TELECOMMUNI-
- 5 CATIONS SERVICE THAT ALLOWS END USERS TO ORIGINATE CALLS THROUGH
- 6 AN ACCESS NUMBER OR AUTHORIZATION CODE.
- 7 (D) "PROVIDER" MEANS A PERSON PROVIDING PREPAID CALLING
- 8 SERVICES TO THE PUBLIC USING ITS OWN OR RESOLD TELECOMMUNICATIONS
- 9 SERVICES. A RETAIL STORE OR OTHER RETAIL DISTRIBUTOR IS A PRO-
- 10 VIDER OF PREPAID CALLING SERVICES IF ITS NAME IS LISTED ON THE
- 11 PREPAID CALLING CARD, OR IF IT OTHERWISE IS PROVIDING ITS OWN OR
- 12 RESOLD TELECOMMUNICATIONS SERVICES.
