

HOUSE BILL No. 5761

May 9, 2000, Introduced by Rep. Vander Roest and referred to the Committee on Senior Health, Security and Retirement.

A bill to amend 1979 PA 218, entitled "Adult foster care facility licensing act,"

(MCL 400.701 to 400.737) by adding section 26b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 26B. (1) BEGINNING NOT MORE THAN 90 DAYS AFTER THE
- 2 EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED THIS SECTION, AN
- 3 ADULT FOSTER CARE LARGE GROUP HOME THAT REPRESENTS TO THE PUBLIC
- 4 THAT IT PROVIDES INPATIENT OR RESIDENTIAL CARE OR SERVICES, OR
- 5 BOTH, TO PERSONS WHO ARE DIAGNOSED AS HAVING ALZHEIMER'S DISEASE
- 6 OR RELATED DISORDERS SHALL PROVIDE TO EACH PROSPECTIVE PATIENT,
- 7 RESIDENT, OR SURROGATE DECISION MAKER A WRITTEN DESCRIPTION OF
- 8 THE SERVICES PROVIDED BY THE ADULT FOSTER CARE LARGE GROUP HOME
- 9 TO PATIENTS OR RESIDENTS WHO ARE DIAGNOSED AS HAVING ALZHEIMER'S
- 10 DISEASE OR RELATED DISORDERS. A WRITTEN DESCRIPTION SHALL
- 11 INCLUDE, BUT NOT BE LIMITED TO, ALL OF THE FOLLOWING:

- 1 (A) THE OVERALL PHILOSOPHY AND MISSION REFLECTING THE NEEDS
- 2 OF RESIDENTS DIAGNOSED AS HAVING ALZHEIMER'S DISEASE OR A RELATED
- 3 DISORDER.
- 4 (B) THE PROCESS AND CRITERIA FOR PLACEMENT IN OR TRANSFER OR
- 5 DISCHARGE FROM A PROGRAM FOR RESIDENTS DIAGNOSED AS HAVING
- 6 ALZHEIMER'S DISEASE OR A RELATED DISORDER.
- 7 (C) THE PROCESS USED FOR ASSESSMENT AND ESTABLISHMENT OF A
- 8 PLAN OF CARE AND ITS IMPLEMENTATION.
- 9 (D) STAFF TRAINING AND CONTINUING EDUCATION PRACTICES.
- 10 (E) THE PHYSICAL ENVIRONMENT AND DESIGN FEATURES APPROPRIATE
- 11 TO SUPPORT THE FUNCTION OF RESIDENTS DIAGNOSED AS HAVING
- 12 ALZHEIMER'S DISEASE OR A RELATED DISORDER.
- 13 (F) THE FREQUENCY AND TYPES OF ACTIVITIES FOR RESIDENTS
- 14 DIAGNOSED AS HAVING ALZHEIMER'S DISEASE OR A RELATED DISORDER.
- 15 (G) IDENTIFICATION OF SUPPLEMENTAL FEES FOR SERVICES PRO-
- 16 VIDED TO PATIENTS OR RESIDENTS DIAGNOSED AS HAVING ALZHEIMER'S
- 17 DISEASE OR A RELATED DISORDER.
- 18 (2) AS USED IN THIS SECTION, "REPRESENTS TO THE PUBLIC"
- 19 MEANS ADVERTISES, MARKETS, OR OTHERWISE PROMOTES THE FACILITY AS
- 20 PROVIDING SPECIALIZED CARE SERVICES FOR ALZHEIMER'S DISEASE OR A
- 21 RELATED DISORDER.
