



# HOUSE BILL No. 5782

May 11, 2000, Introduced by Reps. DeVuyst, Birkholz, Julian, Tabor, Mead, Pumford, Gosselin, Van Woerkom, Howell, DeRossett, Caul, Jelinek, Kuipers, Pappageorge, DeWeese, Hager, Shulman, Woronchak and Cassis and referred to the Committee on Conservation and Outdoor Recreation.

A bill to amend 1927 PA 175, entitled  
"The code of criminal procedure,"  
by amending section 11 of chapter XVII (MCL 777.11), as amended  
by 1999 PA 90.

CHAPTER XVII
