

## **HOUSE BILL No. 5790**

May 16, 2000, Introduced by Reps. DeHart, Schermesser, Hale, Hardman, Scott and Rivet and referred to the Committee on Health Policy.

A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding section 12919.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 12919. (1) SUBJECT TO SUBSECTION (3), UPON RECEIPT OF
- 2 AN INSPECTION REPORT ISSUED BY AN AUTHORIZED REPRESENTATIVE OF
- 3 THE DEPARTMENT OR A LOCAL HEALTH DEPARTMENT AFTER THE MOST RECENT
- 4 COMPLIANCE INSPECTION CONDUCTED UNDER R 325.25901 TO R 325.25910
- 5 OF THE MICHIGAN ADMINISTRATIVE CODE, THE OWNER OR OPERATOR OF A
- 6 FOOD SERVICE ESTABLISHMENT SHALL COMPLY WITH SUBSECTION (2).
- 7 (2) UPON THE REQUEST OF A CUSTOMER, THE OWNER OR OPERATOR OF
- 8 A FOOD SERVICE ESTABLISHMENT SHALL PROVIDE THE CUSTOMER WITH A
- 9 COPY OF THE INSPECTION REPORT DESCRIBED IN SUBSECTION (1).
- 10 (3) IF A FOOD SERVICE ESTABLISHMENT HAS REQUESTED A REVIEW
- 11 OF THE INSPECTION REPORT DESCRIBED IN SUBSECTION (1) UNDER

- 1 R 325.25910 OF THE MICHIGAN ADMINISTRATIVE CODE, THE OWNER OR
- 2 OPERATOR OF THE FOOD SERVICE ESTABLISHMENT MAY NOTE THAT FACT IN
- 3 WRITING ON THE COPY OF THE INSPECTION REPORT PROVIDED TO A CUS-
- 4 TOMER UNDER SUBSECTION (2).
- 5 (4) THE OWNER OR OPERATOR OF A FOOD SERVICE ESTABLISHMENT
- 6 SHALL POST A NOTICE OF THE REQUIREMENTS OF SUBSECTIONS (1) TO (3)
- 7 IN THE SAME MANNER AS REQUIRED FOR THE POSTING OF THE FOOD SERV-
- 8 ICE ESTABLISHMENT'S LICENSE UNDER SECTION 12904(5). THE TEXT OF
- 9 THE NOTICE SHALL BE IN AT LEAST 32-POINT BOLDFACED TYPE AND SHALL
- 10 BE PRINTED ON PAPER AT LEAST 11 INCHES BY 17 INCHES IN SIZE.
