

HOUSE BILL No. 5791

May 16, 2000, Introduced by Reps. Bob Brown, Prusi, DeHart, Schermesser, Callahan, Sheltrown, Pappageorge, Dennis, Pestka, Garcia, Martinez, Rivet, Ehardt, Rocca, Scott, Bogardus, Bovin, Neumann, Schauer, Spade and Raczkowski and referred to the Committee on Tax Policy.

A bill to amend 1967 PA 281, entitled "Income tax act of 1967," by amending section 506 (MCL 206.506), as amended by 1996 PA 484.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 506. (1) "Eligible serviceperson", "eligible veteran",
- 2 and "eligible widow or widower" means MEAN a serviceperson,
- 3 veteran, or widow or widower, whose income as defined in this
- 4 chapter is not more than \$7,500.00 per year unless the service-
- 5 person, veteran, or widow or widower receives compensation paid
- 6 by the veterans administration or the armed forces of the United
- 7 States for service incurred disabilities and who meets the
- 8 requirements of the following schedule:
