

HOUSE BILL No. 5873

June 7, 2000, Introduced by Rep. Faunce and referred to the Committee on Tax Policy.

A bill to amend 1893 PA 206, entitled "The general property tax act,"

(MCL 211.1 to 211.157) by adding section 7gg.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 7GG. (1) THE GOVERNING BODY OF A LOCAL TAX COLLECTING
- 2 UNIT MAY BY RESOLUTION EXEMPT FROM THE COLLECTION OF TAXES UNDER
- 3 THIS ACT ALL NEW CONSTRUCTION ON HOMESTEAD PROPERTY FOR THE
- 4 PERIOD PROVIDED IN SUBSECTION (2). BEFORE ACTING ON THE RESOLU-
- 5 TION, THE CLERK OF THE LOCAL TAX COLLECTING UNIT SHALL NOTIFY IN
- 6 WRITING THE ASSESSOR OF THE LOCAL TAX COLLECTING UNIT AND THE
- 7 LEGISLATIVE BODY OF EACH TAXING UNIT THAT LEVIES AD VALOREM PROP-
- 8 ERTY TAXES IN THE LOCAL TAX COLLECTING UNIT AND SHALL AFFORD THE
- 9 ASSESSOR AND A REPRESENTATIVE OF THE AFFECTED TAXING UNITS AN
- 10 OPPORTUNITY FOR A HEARING ON THE PROPOSED RESOLUTION.

- 1 (2) THE EXEMPTION UNDER THIS SECTION IS EFFECTIVE ON THE
- 2 DECEMBER 31 IMMEDIATELY SUCCEEDING THE ADOPTION OF THE RESOLUTION
- 3 BY THE GOVERNING BODY OF THE LOCAL TAX COLLECTING UNIT. THE
- 4 EXEMPTION SHALL CONTINUE IN EFFECT UNTIL THE HOMESTEAD PROPERTY
- 5 IS TRANSFERRED OR FOR A PERIOD SPECIFIED IN THE RESOLUTION WHICH
- 6 SHALL NOT BE MORE THAN 5 YEARS, WHICHEVER IS SOONER. A COPY OF
- 7 THE RESOLUTION SHALL BE FILED WITH THE STATE TAX COMMISSION.
- 8 (3) AS USED IN THIS SECTION:
- 9 (A) "HOMESTEAD" MEANS THAT TERM AS DEFINED UNDER SECTION
- **10** 7DD.
- 11 (B) "HOMESTEAD PROPERTY" MEANS A HOMESTEAD EXEMPT UNDER SEC-
- 12 TION 7CC FROM THE TAX LEVIED BY A LOCAL SCHOOL DISTRICT FOR
- 13 SCHOOL OPERATING PURPOSES TO THE EXTENT PROVIDED UNDER SECTION
- 14 1211 OF THE REVISED SCHOOL CODE, 1976 PA 451, MCL 380.1211.
- 15 (C) "NEW CONSTRUCTION" MEANS THAT TERM AS DEFINED IN SECTION
- **16** 34D(1)(B)(*iii*).
- 17 (D) "TRANSFERRED" MEANS A TRANSFER OF OWNERSHIP AS THAT TERM
- 18 IS DESCRIBED IN SECTION 27A.
