

## **HOUSE BILL No. 5876**

June 8, 2000, Introduced by Rep. Bovin and referred to the Committee on Tax Policy.

A bill to amend 1967 PA 281, entitled "Income tax act of 1967,"

(MCL 206.1 to 206.532) by adding section 267.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 267. (1) FOR TAX YEARS THAT BEGIN AFTER DECEMBER 31,
- 2 1999, A TAXPAYER MAY CLAIM A CREDIT AGAINST THE TAX IMPOSED BY
- 3 THIS ACT EQUAL TO THE 50% OF THE COST PAID BY THE TAXPAYER, NOT
- 4 TO EXCEED \$5,000.00, FOR QUALIFIED RENOVATIONS MADE TO THE HOME
- 5 OF THE TAXPAYER IF THE TAXPAYER IS EITHER OF THE FOLLOWING:
- 6 (A) A SENIOR CITIZEN OR PERSON WITH A DISABILITY WHO MAKES
- 7 RENOVATIONS TO HIS OR HER OWN HOME.
- 8 (B) A TAXPAYER, OTHER THAN A TAXPAYER DESCRIBED IN SUBDIVI-
- 9 SION (A), IF A SENIOR CITIZEN OR PERSON WITH A DISABILITY LIVES
- 10 IN THE HOME OF THE TAXPAYER WHO MAKES THE QUALIFIED RENOVATIONS.

- 1 (2) THE CREDIT ALLOWED UNDER THIS SECTION SHALL BE TAKEN
- 2 ONLY IN THE YEAR IN WHICH ALL QUALIFIED RENOVATIONS FOR WHICH A
- 3 CREDIT UNDER THIS SECTION WILL BE CLAIMED ARE COMPLETED AND SHALL
- 4 BE CLAIMED FOR ONLY 1 TAX YEAR FOR QUALIFIED RENOVATIONS MADE BY
- 5 OR ON BEHALF OF ANY 1 SENIOR CITIZEN OR PERSON WITH A
- 6 DISABILITY.
- 7 (3) IF THE CREDIT ALLOWED UNDER THIS SECTION EXCEEDS THE TAX
- 8 LIABILITY OF THE TAXPAYER FOR THE TAX YEAR, THE AMOUNT BY WHICH
- 9 THE CREDIT EXCEEDS THE TAXPAYER'S TAX LIABILITY SHALL BE
- 10 REFUNDED.
- 11 (4) AS USED IN THIS SECTION:
- 12 (A) "HOME" MEANS A HOMESTEAD EXEMPT UNDER SECTION 7CC OF THE
- 13 GENERAL PROPERTY TAX ACT, 1893 PA 206, MCL 211.7CC.
- 14 (B) "QUALIFIED RENOVATIONS" MEANS RENOVATIONS, ADDITIONS, OR
- 15 OTHER CONSTRUCTION MADE TO A HOME THAT ARE ANY OF THE FOLLOWING:
- 16 (i) CHANGES TO ACCOMMODATE THE PHYSICAL NEEDS OF A SENIOR
- 17 CITIZEN OR PERSON WITH A DISABILITY, INCLUDING, BUT NOT LIMITED
- 18 TO, BATH BARS, RAMPS, DOOR WIDENING, ACCESS CHANGES, AND REFIT-
- 19 TING OF FIXTURES.
- 20 (ii) ADDITION OF A ROOM.
- 21 (iii) ANY CHANGE TO THE HOME THAT IS MADE TO MEET LOCAL OR
- 22 STATE BUILDING CODES, ORDINANCES, STATUTES, OR RULES THAT REGU-
- 23 LATE HOUSING FOR PERSONS WITH DISABILITIES.
- (iv) SAFETY FEATURES.
- 25 (C) "PERSON WITH A DISABILITY" MEANS THAT TERM AS DEFINED IN
- 26 SECTION 103 OF THE PERSONS WITH DISABILITIES CIVIL RIGHTS ACT,
- **27** 1976 PA 220, MCL 37.1103.

1 (D) "SENIOR CITIZEN" MEANS A PERSON WHO IS 65 YEARS OF AGE

2 OR OLDER.
