

HOUSE BILL No. 5891

June 20, 2000, Introduced by Rep. Bradstreet and referred to the Committee on Transportation.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

(MCL 257.1 to 257.923) by adding section 811d.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 811D. (1) THE SECRETARY OF STATE SHALL DEVELOP AND,
- 2 UPON APPLICATION, MAY ISSUE A MICHIGAN CONSERVATION DISTRICTS
- 3 REGISTRATION PLATE TO AN APPLICANT FOR USE ON THE PASSENGER MOTOR
- 4 VEHICLE, PICKUP TRUCK, VAN, MOTOR HOME, HEARSE, BUS, TRAILER
- 5 COACH, OR TRAILER FOR WHICH THE REGISTRATION PLATE IS ISSUED
- 6 INSTEAD OF A STANDARD REGISTRATION PLATE. MICHIGAN CONSERVATION
- 7 DISTRICTS REGISTRATION PLATES SHALL BEAR LETTERS AND NUMBERS THAT
- 8 THE SECRETARY OF STATE PRESCRIBES. THE PLATE SHALL BE OF A
- 9 DESIGN AS SUBMITTED BY 1 OR MORE MICHIGAN CONSERVATION DISTRICTS
- 10 AS DETERMINED BY THE SECRETARY OF STATE. THE WORD "MICHIGAN"

- 1 SHALL APPEAR ON EACH MICHIGAN CONSERVATION DISTRICTS REGISTRATION
- 2 PLATE.
- 3 (2) AN APPLICATION FOR A MICHIGAN CONSERVATION DISTRICTS
- 4 REGISTRATION PLATE SHALL BE SUBMITTED TO THE SECRETARY OF STATE
- 5 PURSUANT TO THE PROCEDURES PRESCRIBED IN SECTION 217.
- 6 APPLICATION FOR AN ORIGINAL OR RENEWAL MICHIGAN CONSERVATION DIS-
- 7 TRICTS REGISTRATION PLATE SHALL BE ACCOMPANIED WITH PAYMENT OF
- 8 THE REGULAR VEHICLE REGISTRATION TAX IN ADDITION TO A SERVICE FEE
- 9 AS FOLLOWS:
- 10 (A) FOR AN ORIGINAL MICHIGAN CONSERVATION DISTRICTS REGIS-
- 11 TRATION PLATE, \$3.00 FOR THE FIRST MONTH AND \$2.00 PER MONTH FOR
- 12 EACH ADDITIONAL MONTH OF THE REGISTRATION PERIOD.
- 13 (B) FOR A RENEWAL MICHIGAN CONSERVATION DISTRICTS REGISTRA-
- **14** TION PLATE, \$10.00.
- 15 (3) A MICHIGAN CONSERVATION DISTRICTS REGISTRATION PLATE
- 16 SHALL EXPIRE AS DESCRIBED IN SECTION 226. UPON THE ISSUANCE OR
- 17 RENEWAL OF A MICHIGAN CONSERVATION DISTRICTS REGISTRATION PLATE,
- 18 THE SECRETARY OF STATE MAY ISSUE A TAB OR TABS DESIGNATING THE
- 19 MONTH AND YEAR OF EXPIRATION.
- 20 (4) THE SECRETARY OF STATE MAY ISSUE A TEMPORARY REGISTRA-
- 21 TION PERMIT TO A PERSON WHO SUBMITS AN APPLICATION AND THE PROPER
- 22 PAYMENTS FOR A MICHIGAN CONSERVATION DISTRICTS REGISTRATION PLATE
- 23 IF THE APPLICANT'S CURRENT VEHICLE REGISTRATION WILL EXPIRE
- 24 BEFORE HIS OR HER RECEIPT OF A MICHIGAN CONSERVATION DISTRICTS
- 25 REGISTRATION PLATE. THE TEMPORARY REGISTRATION SHALL EXPIRE UPON
- 26 RECEIPT OF A MICHIGAN CONSERVATION DISTRICTS REGISTRATION PLATE
- 27 OR 60 DAYS AFTER THE ISSUANCE OF A MICHIGAN CONSERVATION

- 1 DISTRICTS REGISTRATION PLATE, WHICHEVER OCCURS FIRST. THE
- 2 TEMPORARY PERMIT SHALL BE ISSUED WITHOUT A SEPARATE FEE.
- 3 (5) MICHIGAN CONSERVATION DISTRICTS REGISTRATION PLATE SERV-
- 4 ICE FEES COLLECTED UNDER THIS SECTION BY THE SECRETARY OF STATE
- 5 SHALL BE IDENTIFIED AND SEGREGATED BY THE SECRETARY OF STATE INTO
- 6 A SEPARATE ACCOUNT. AFTER DEDUCTING THE MANUFACTURING AND ADMIN-
- 7 ISTRATIVE COSTS OF THE SECRETARY OF STATE, INCLUDING ADMINISTRA-
- 8 TIVE COSTS ASSOCIATED WITH ISSUING, REPLACING, AND SUBSTITUTING
- 9 PLATES, THE SECRETARY OF STATE SHALL ON A QUARTERLY BASIS TRANS-
- 10 FER THE BALANCE OF THE MICHIGAN CONSERVATION DISTRICTS REGISTRA-
- 11 TION PLATE SERVICE FEES TO THE STATE TREASURER WHO SHALL CREDIT
- 12 THE FEE MONEY TO THE MICHIGAN CONSERVATION DISTRICTS FUND CREATED
- 13 IN SECTION 9315 OF THE NATURAL RESOURCES AND ENVIRONMENTAL PRO-
- 14 TECTION ACT, 1994 PA 451, MCL 324.9315. THESE FUNDS SHALL BE
- 15 USED EXCLUSIVELY FOR THE PURPOSE OF FULFILLING THE RESPONSIBILI-
- 16 TIES OF MICHIGAN CONSERVATION DISTRICTS DESCRIBED UNDER PART 93
- 17 OF THE NATURAL RESOURCES AND ENVIRONMENTAL PROTECTION ACT, 1994
- 18 PA 451, MCL 324.9301 TO 324.9315, AND AS OTHERWISE PROVIDED BY
- **19** LAW.
- 20 (6) FOR PURPOSES OF THIS SECTION:
- 21 (A) "MICHIGAN CONSERVATION DISTRICT" MEANS CONSERVATION DIS-
- 22 TRICT AS THAT TERM IS DEFINED IN SECTION 9301 OF THE NATURAL
- 23 RESOURCES AND ENVIRONMENTAL PROTECTION ACT, 1994 PA 451, MCL
- **24** 324.9301.
- 25 (B) "MICHIGAN CONSERVATION DISTRICTS REGISTRATION PLATE"
- 26 MEANS A REGISTRATION PLATE CONTAINING A SPECIALIZED DESIGN
- 27 PERTAINING TO MICHIGAN'S CONSERVATION DISTRICTS.

- 4 is enacted into law.
