

## **HOUSE BILL No. 5929**

June 21, 2000, Introduced by Reps. Patterson, Richardville, Julian, Gilbert, Tabor, Koetje, O'Neil, Shulman, Kowall, Kuipers, Van Woerkom, Faunce, Ehardt, Bishop, Vear, Mortimer, Richner, Cameron Brown, Bisbee, Law, LaSata, Toy, DeVuyst, Howell, Bovin, Pappageorge, DeRossett and Jansen and referred to the Committee on Criminal Law and Corrections.

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 16x of chapter XVII (MCL 777.16x), as added by 1998 PA 317.
