

## **HOUSE BILL No. 6075**

October 4, 2000, Introduced by Reps. Woodward, Jacobs, Wojno, Hansen, Switalski, Bogardus, Dennis, Minore, Gieleghem, Quarles and Lockwood and referred to the Committee on Criminal Law and Corrections.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 411r.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 411R. (1) EXCEPT AS PROVIDED IN SUBSECTION (3), A
- 2 PERSON WHO ATTENDS AN EDUCATIONAL INSTITUTION SHALL NOT ENGAGE IN
- 3 OR PARTICIPATE IN THE HAZING OF ANOTHER PERSON.
- 4 (2) A PERSON WHO VIOLATES SUBSECTION (1) IS GUILTY OF A MIS-
- 5 DEMEANOR PUNISHABLE BY THE FOLLOWING:
- 6 (A) FIFTY HOURS OF COMMUNITY SERVICE.
- **7** (B) IMPRISONMENT FOR NOT MORE THAN 30 DAYS, IF THE DEFENDANT
- 8 FAILS TO PERFORM COMMUNITY SERVICE AS ORDERED UNDER THIS
- 9 SECTION.

- 1 (3) THIS SECTION DOES NOT APPLY TO A PERSON WHO IS THE
- 2 SUBJECT OF THE HAZING, REGARDLESS OF WHETHER THE PERSON
- 3 VOLUNTARILY ALLOWED HIMSELF OR HERSELF TO BE HAZED.
- 4 (4) A CRIMINAL PENALTY PROVIDED FOR UNDER THIS SECTION MAY
- 5 BE IMPOSED IN ADDITION TO ANY PENALTY THAT MAY BE IMPOSED FOR ANY
- 6 OTHER CRIMINAL OFFENSE ARISING FROM THE SAME CONDUCT.
- 7 (5) AS USED IN THIS SECTION:
- 8 (A) "EDUCATIONAL INSTITUTION" MEANS A PUBLIC OR PRIVATE
- 9 SCHOOL THAT IS A MIDDLE SCHOOL, JUNIOR HIGH SCHOOL, OR HIGH
- 10 SCHOOL LOCATED IN THIS STATE.
- 11 (B) "HAZING" MEANS A METHOD OF INITIATION OR PRE-INITIATION
- 12 INTO A STUDENT ORGANIZATION OR A PASTIME OR AMUSEMENT ENGAGED IN
- 13 CONCERNING A STUDENT ORGANIZATION THAT CAUSES, OR IS LIKELY TO
- 14 CAUSE, BODILY INJURY OR PERSONAL DEGRADATION OR DISGRACE THAT
- 15 RESULTS IN PHYSICAL OR MENTAL HARM TO ANOTHER PERSON WHO ATTENDS
- 16 THE EDUCATIONAL INSTITUTION. HAZING DOES NOT INCLUDE CUSTOMARY
- 17 ATHLETIC EVENTS OR OTHER SIMILAR CONTESTS OR COMPETITIONS.
