- 3 AND PHYSICAL PAIN AND SUFFERING, THAT RESULT FROM THE HAZING.
- 4 THE ACTION MAY BE BROUGHT AGAINST A PARTICIPANT IN THE HAZING OR
- 5 AN ORGANIZATION WHOSE LOCAL OR NATIONAL DIRECTORS, TRUSTEES, OR
- 6 OFFICERS AUTHORIZED, REQUESTED, COMMANDED, OR TOLERATED THE
- 7 HAZING.
- 8 (2) IF THE HAZING INVOLVES A STUDENT IN A PRIMARY, SECOND-
