A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding section 21734.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 21734. (1) IF A NURSING HOME HAS A POLICY PROHIBITING
- 2 THE USE OF SAFETY RAILS ON HOSPITAL-TYPE BEDS, THE NURSING HOME
- 3 SHALL GIVE EACH RESIDENT WHO USES A HOSPITAL-TYPE BED OR THE
- 4 RESIDENT'S LEGAL REPRESENTATIVE THE OPTION OF HAVING SAFETY RAILS
- 5 ON THE BED. A NURSING HOME SHALL OFFER THE OPTION TO NEW RESI-
- 6 DENTS UPON ADMISSION AND TO OTHER RESIDENTS UPON REQUEST.
- 7 (2) IF A RESIDENT OR HIS OR HER LEGAL REPRESENTATIVE CHOOSES
- 8 SAFETY RAILS UNDER SUBSECTION (1), THE NURSING HOME MAY REQUIRE
- 9 THE RESIDENT OR LEGAL REPRESENTATIVE TO SIGN A STATEMENT WAIVING
- 10 THE RESIDENT'S RIGHT TO FILE A CIVIL ACTION FOR DAMAGES FOR AN
- 11 INJURY CAUSED BY THE USE OF THE SAFETY RAILS IF THE INJURY IS NOT
