- 5 THE TREATMENT OF DIABETES, IF RECOMMENDED OR PRESCRIBED BY A
- 6 PHYSICIAN:
- 7 (A) BLOOD GLUCOSE MONITORS AND BLOOD GLUCOSE MONITORS FOR
- 8 THE LEGALLY BLIND.
- **9** (B) DATA MANAGEMENT SYSTEMS.
- 10 (C) TEST STRIPS FOR GLUCOSE MONITORS AND VISUAL READING AND
- 11 URINE TESTING STRIPS.
