- 9 OF HONOR MAY APPLY TO THE SECRETARY OF STATE FOR A SPECIAL

- 1 SECRETARY OF STATE, AND SHALL BE ACCOMPANIED BY ANY PROOF OF THE

- 26 PLATE IS ISSUED, OR BY A PERSON WHO DOES NOT QUALIFY UNDER THIS
- 27 SECTION, IS A MISDEMEANOR.
