THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 411R. (1) A PERSON SHALL NOT DO ANY OF THE FOLLOWING:
- 2 (A) THREATEN TO DAMAGE OR DESTROY SCHOOL PROPERTY.
- 3 (B) THREATEN TO KILL OR PHYSICALLY INJURE ANY PERSON ON
- 4 SCHOOL PROPERTY.
- 5 (C) THREATEN TO KILL OR PHYSICALLY INJURE ANY PERSON BECAUSE
- 6 OF HIS OR HER STATUS AS A SCHOOL EMPLOYEE OR BECAUSE OF HIS OR
- 7 HER STATUS AS A STUDENT AT A SCHOOL.
- 8 (2) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A MISDE-
- 9 MEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 1 YEAR OR A
- 10 FINE OF NOT MORE THAN \$1,000.00, OR BOTH.

- 1 (3) THIS SECTION DOES NOT PROHIBIT THE PERSON FROM BEING

- 9 (B) "SCHOOL PROPERTY" MEANS ANY REAL OR PERSONAL PROPERTY
- 10 OWNED BY A SCHOOL OR ANY OTHER PROPERTY WHILE IT IS BEING USED BY
- 11 A SCHOOL FOR A SCHOOL FUNCTION, EVENT, OR ACTIVITY.

- 14 Enacting section 2. This amendatory act does not take
- 15 effect unless Senate Bill No. 1222
- of the 90th Legislature is enacted into
