- 1. **Buy American.** House added that preference is to be given to Michigan-produced goods and services. (Sec.
- 2. Aircraft Plans. The House removed language calling for Department use of King Air aircraft from MDOT when feasible. (Sec. 217)
- 3. VIN Access. The House added that public access to VIN numbers in accident data be provided at cost. (Sec.
- Budgetary Savings. The House included this section. (Sec. 208)
- Truck Safety Grant. The House removed this section that would authorize \$1,500,000 in grants for the Michigan Center for Truck Safety. (Sec. 402)
- Criminal Justice Fees. The House removed this section which would allow for receipt and expenditure of concealed weapons fees which may exceed budgeted amount. (Sec. 501)
- **Probation Data.** The House rejected language stating legislative intent to have officers have access to probation information about a person. (Sec. 604)
- City of Detroit Grant. The House removed language authorizing a portion of the State grant to the Detroit Police Special Events account. (Sec. 701)
- Evidence Collection Study. The House altered Senate language calling for a study of improper evidence collection in sexual assault cases, by requiring the Department, in conjunction with Wayne County, to develop recommendations concerning these collections. (Sec. 703)
- 10. **Red Cross.** The House removed language requiring cooperation and help to the Red Cross in their mission. (Sec. 1002)
- 11. Aeronautics Officer. The House removed language that would require the Department to help pay for an aeronautics safety officer within MDOT to coordinate safety functions with departments that utilize civilian aircraft. (Sec. 1202)
- 12. **Security Guards.** The House removed the requirement that MCOLES develop standards for private security guard regulation. (Sec. 1302)
