THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1344. (1) A juror shall be ~~paid mileage~~ REIMBURSED
2 FOR HIS OR HER TRAVELING EXPENSES at a rate, determined by the
3 county board of commissioners, ~~which~~ THAT is not less than 10
4 cents per mile for traveling ~~expenses~~ from the juror's resi-
5 dence to the place of holding court and ~~return~~ RETURNING for
6 each day or 1/2 day of actual attendance at sessions of the
7 court. ~~The~~
- 8 (2) A juror also shall be compensated at a rate, determined
9 by the county board of commissioners, ~~which is~~ AS FOLLOWS:

1 (A) UNTIL OCTOBER 1, 2002, not less than \$15.00 per day and
2 \$7.50 per 1/2 day of actual attendance at the court.

3 (B) BEGINNING OCTOBER 1, 2002, A RATE DETERMINED AS
4 FOLLOWS:

5 (i) FOR THE FIRST DAY OF ACTUAL ATTENDANCE AT THE COURT, NOT
6 LESS THAN \$15.00 PER DAY; AND FOR THE SECOND DAY AND EACH SUBSE-
7 QUENT DAY OF ACTUAL ATTENDANCE AT THE COURT, NOT LESS THAN \$40.00
8 PER DAY.

9 (ii) FOR THE FIRST 1/2 DAY OF ACTUAL ATTENDANCE AT THE
10 COURT, NOT LESS THAN \$7.50 PER 1/2 DAY; AND FOR THE SECOND 1/2
11 DAY AND EACH SUBSEQUENT 1/2 DAY OF ACTUAL ATTENDANCE AT THE
12 COURT, NOT LESS THAN \$20.00 PER 1/2 DAY.

13 (3) If an action is removed from the circuit court to a
14 lower court, the jury fee shall be paid to the circuit court
15 whether paid before or after removal of the action to the lower
16 court, and the circuit court shall be responsible for payment of
17 the compensation to the juror involved.

18 (4) A clerk or deputy clerk of the court who fraudulently
19 issues a certificate of attendance of a juror on which the juror
20 receives pay, except as allowed by law, is guilty of a misdemean-
21 or, punishable by imprisonment for not more than 6 months, or a
22 fine of not more than \$500.00, or both.

23 Enacting section 1. This amendatory act takes effect
24 October 1, 2002.

25 Enacting section 2. This amendatory act does not take
26 effect unless all of the following bills of the 91st Legislature
27 are enacted into law:
