## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 506D. (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS
- 2 ACT, THE COURT MAY ORDER AN INDIVIDUAL CONVICTED OF COMMITTING A
- 3 VIOLATION OF THIS ACT IN WHICH AN INDIVIDUAL WHO IS A PATIENT OR
- 4 A RESIDENT OF A NURSING HOME, HOME FOR THE AGED, COUNTY MEDICAL
- 5 CARE FACILITY, OR ADULT FOSTER CARE FACILITY IS A VICTIM OF THAT
- 6 VIOLATION TO PAY NOT MORE THAN TWICE THE FINE OTHERWISE AUTHO-
- 7 RIZED FOR THAT VIOLATION OR TO PAY A FINE AUTHORIZED UNDER SUB-
- 8 SECTION (2). [FINES DO NOT INCLUDE COURT COSTS OR OTHER ASSESSMENTS.] AS USED IN THIS SUBSECTION:
- 9 (A) "ADULT FOSTER CARE FACILITY" MEANS A FACILITY LICENSED
- 10 UNDER THE ADULT FOSTER CARE FACILITY LICENSING ACT, 1979 PA 218,

- 1 (B) "COUNTY MEDICAL CARE FACILITY", "HOME FOR THE AGED", AND
- 2 "NURSING HOME" MEAN A HEALTH FACILITY OR AGENCY LICENSED AS A

- 11 (B) A FINE OF NOT MORE THAN \$500.00 IF THE VIOLATION IS A
- 12 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR 6 MONTHS.
- 13 (C) A FINE OF NOT MORE THAN \$1,000.00 IF THE VIOLATION IS A
- 14 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR 1 YEAR.
- 15 (D) A FINE OF NOT MORE THAN \$2,000.00 IF THE VIOLATION IS A
- 16 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR MORE THAN 1 YEAR BUT
- 17 NOT MORE THAN 2 YEARS OR IF THE VIOLATION IS A FELONY PUNISHABLE
- 18 BY IMPRISONMENT FOR NOT MORE THAN 2 YEARS.
- 19 (E) A FINE OF NOT MORE THAN \$4,000.00 IF THE VIOLATION IS A
- 20 FELONY PUNISHABLE BY IMPRISONMENT FOR MORE THAN 2 YEARS BUT NOT
- 21 MORE THAN 4 YEARS.
- 22 (F) A FINE OF NOT MORE THAN \$5,000.00 IF THE VIOLATION IS A
- 23 FELONY PUNISHABLE BY IMPRISONMENT FOR 5 YEARS.
- 24 (G) A FINE OF NOT MORE THAN \$10,000.00 IF THE VIOLATION IS A
- 25 FELONY PUNISHABLE BY IMPRISONMENT FOR MORE THAN 5 YEARS.
