# SUBSTITUTE FOR HOUSE BILL NO. 4300

#### A bill to amend 1931 LA 1, entitled

"An act to prevent hunting on Sunday, in the county of Lenawee; to authorize the arrest of persons violating the provisions of this act, and to prescribe the penalty therefor,"

by amending section 6 and by adding section 5a; to provide for a referendum; and to repeal acts and parts of acts.

#### THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 5A. (1) SECTION 1 DOES NOT APPLY TO A PERSON ENGAGED
- 2 IN THE PRODUCTION OF LIVESTOCK ON A PARCEL OF LAND IN THE COUNTY
- 3 OF LENAWEE, OR HIS OR HER DESIGNEE, IF BOTH OF THE FOLLOWING
- 4 APPLY:
- 5 (A) THE PERSON OR DESIGNEE POSSESSES A WRITTEN SUNDAY HUNT-
- 6 ING EXEMPTION ISSUED UNDER SUBSECTION (2).
- 7 (B) THE PERSON OR DESIGNEE IS HUNTING COYOTE, FOX, OR
- 8 RACCOON ON THAT PARCEL OR ON A CONTIGUOUS PARCEL OWNED OR LEASED
- 9 BY THAT PERSON OR BY AN IMMEDIATE FAMILY MEMBER OF THAT PERSON.
