- 1 SEC. 20188. (1) THE GOVERNOR'S COMMISSION ON PATIENT SAFETY
- 2 IS CREATED IN THE DEPARTMENT OF COMMUNITY HEALTH. THE GOVERNOR
- 3 SHALL APPOINT THE COMMISSION ON PATIENT SAFETY. THE COMMISSION
- 4 ON PATIENT SAFETY SHALL CONSULT WITH OR SEEK INPUT FROM THE
- 5 PUBLIC AND FROM ALL OF THE FOLLOWING ORGANIZATIONS THAT HAVE AN
- 6 INTEREST IN PATIENT SAFETY:

 - 9 [(X)] THE MICHIGAN HOME HEALTH ASSOCIATION OR ITS SUCCESSOR
- 10 ORGANIZATION.
- 11 (2) THE COMMISSION ON PATIENT SAFETY SHALL MEET AND APPOINT
- 12 A CHAIRPERSON WITHIN 30 DAYS AFTER ALL MEMBERS ARE APPOINTED BY
- 13 THE GOVERNOR. SUBSEQUENTLY, THE COMMISSION SHALL MEET AT THE
- 14 CALL OF THE CHAIRPERSON OR AT THE REQUEST OF A MAJORITY OF THE
- 15 COMMISSION. A MAJORITY OF THE COMMISSION CONSTITUTES A QUORUM
- 16 FOR THE TRANSACTION OF BUSINESS. A MEMBER OF THE COMMISSION
- 17 SHALL SERVE FOR A TERM OF 1 YEAR. A VACANCY ON THE COMMISSION
- 18 SHALL BE FILLED BY THE GOVERNOR IN THE SAME MANNER AND FROM THE
- 19 SAME CATEGORY AS THE ORIGINAL APPOINTMENT.
- 20 (3) THE COMMISSION SHALL REVIEW INFORMATION FROM OTHER
- 21 PATIENT SAFETY INITIATIVES AND STUDY THE CAUSES OF MEDICAL ERRORS
- 22 OCCURRING IN THE CONTINUUM OF CARE, INCLUDING IN HEALTH FACILI-
- 23 TIES AND IN PRIVATE PRACTICES. NOT LATER THAN THE EXPIRATION OF
- 24 1 YEAR AFTER THE COMMISSION IS APPOINTED BY THE GOVERNOR, THE
- 25 COMMISSION SHALL ISSUE A WRITTEN REPORT. THE REPORT SHALL CON-
- 26 TAIN RECOMMENDATIONS FOR IMPROVEMENTS IN MEDICAL PRACTICE AND A
