A bill to amend 1954 PA 116, entitled "Michigan election law," by amending section 482 (MCL 168.482), as amended by 1998 PA 142.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 482. (1) Each EXCEPT AS OTHERWISE PROVIDED IN THIS
- 2 SUBSECTION, EACH petition SHEET under this section shall be 8-1/2
- 3 inches by 14 inches in size, IN HORIZONTAL FORMAT, AND SHALL CON-
- 4 TAIN NO FEWER THAN 7 SIGNATURE LINES. AN 8-1/2 INCHES BY 11
- 5 INCHES PETITION SHEET [, IN EITHER HORIZONTAL OR VERTICAL FORMAT,] MAY BE USED IF IT OTHERWISE COMPLIES WITH
- 6 THIS SECTION AND IF BOTH OF THE FOLLOWING CONDITIONS ARE MET:
- 7 (A) THE FULL TEXT OF THE PROPOSAL IS ABLE TO BE PRINTED ON 1
- 8 OR BOTH SIDES OF AN 8-1/2 INCHES BY 11 INCHES PETITION SHEET.
- 9 (B) EACH PETITION SHEET THAT IS SUBMITTED IS 8-1/2 INCHES BY
- 10 11 INCHES IN SIZE.

- 7 A person who knowingly signs this petition more than once,

- 9 fied and registered elector, or sets opposite his or her signa-
- 10 ture on a petition, a date other than the actual date the signa-
- 11 ture was affixed, is violating the provisions of the Michigan
- 12 election law.
- 13 (6) The remainder of the petition form shall be as provided
- 14 following the warning to electors signing the petition in section
- 15 544c(1). In addition, the petition shall comply with the
- 16 requirements of section 544c(2).
