

**SUBSTITUTE FOR
HOUSE BILL NO. 4912**

[A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"
by amending sections 43701, 43702, 43703, and 43704
(MCL 324.43701, 324.43702, 324.43703, and 324.43704), as added by
1995 PA 57 and by adding section 43705.]

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 43701. As used in this part:

2 (a) "Game and fish protection fund" means the game and fish
3 protection fund in the department of treasury that is created in
4 part 435.

5 (b) "Gas" means a mixture of hydrocarbons and nonhydrocar-
6 bons in a gaseous state which may or may not be associated with
7 oil and includes liquids resulting from the condensation of those
8 hydrocarbons and nonhydrocarbons.

1 (c) "Mineral" means an inorganic substance that can be
2 extracted from the earth, except for oil or gas, and includes
3 rock, metal ores, and mineral water.

4 (d) "Oil" means natural crude oil or petroleum and other
5 hydrocarbons, regardless of gravity, which are produced at the
6 well in liquid form by ordinary production methods and which are
7 not the result of condensation of gas after it leaves the under-
8 ground reservoir.

9 (e) ["Trust] fund" means the game and fish
10 [protection trust] fund established in section
11 43702.

12 Sec. 43702. The game and fish [protection trust
13] fund is created for the benefit of the people of
14 this state and shall consist of the following:

15 (a) Gifts, grants, or bequests conveyed to the trust fund,
16 or income derived from such gifts, grants, or bequests.

17 (b) All funds transferred to the game and fish protection
18 fund by section 1909(a).

19] fund shall be deposited in the game and fish pro-
20 tection fund. ~~The~~

21 (2) SUBJECT TO SUBSECTION (3), THE corpus of the [trust
22] fund shall be maintained by the state treasurer in
23 a manner that will provide for future disbursements to the game
24 and fish protection fund from the [trust] fund's
25 interest and earnings.

[SEC. 43705. A JOINT LEGISLATIVE WORK GROUP ON GAME AND FISH
PROGRAM REVENUE IS ESTABLISHED. THIS WORK GROUP SHALL CONSIST OF
REPRESENTATIVES OF THE HOUSE AND SENATE STANDING COMMITTEES WITH
PRIMARY RESPONSIBILITY FOR NATURAL RESOURCES ISSUES AND THE HOUSE
AND SENATE APPROPRIATIONS SUBCOMMITTEES ON NATURAL RESOURCES.
MEMBERS SHALL BE APPOINTED ON A BIPARTISAN BASIS BY THE SPEAKER OF
THE HOUSE OF REPRESENTATIVES AND THE SENATE MAJORITY LEADER. THE
WORK GROUP SHALL ALSO INCLUDE REPRESENTATIVES OF THE NATURAL
RESOURCES COMMISSION AND STAKEHOLDERS. ASSISTANCE AND STAFF SUPPORT
TO THE WORK GROUP MAY BE PROVIDED BY THE HOUSE AND SENATE FISCAL
AGENCIES. THE WORK GROUP SHALL ISSUE A REPORT BY SEPTEMBER 30,
2002, TO THE MEMBERS OF THE LEGISLATURE WHICH INCLUDES TAX CREDIT
ISSUES AND ALTERNATIVE FUNDING OPTIONS TO ESTABLISH STABLE SOURCES
OF LONG-TERM FINANCIAL SUPPORT FOR GAME AND FISH PROTECTION
PROGRAMS.]
