# SUBSTITUTE FOR HOUSE BILL NO. 4940

A bill to amend 1982 PA 540, entitled "Library of Michigan act,"

by amending the title and sections 2, 3, 4, 5, 6, 7, 10, and 11 (MCL 397.12, 397.13, 397.14, 397.15, 397.16, 397.17, 397.20, and 397.21), the title and sections 2, 4, and 6 as amended by 1995 PA 190 and sections 3, 5, 7, and 10 as amended by 1983 PA 114, and by adding section 10a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 TITLE
- 2 An act to create the library of Michigan; to create a board
- 3 of trustees for the library; to establish the qualifications of
- 4 the state librarian; to provide the powers and duties of the
- 5 board of trustees, the legislative council, the council
- 6 administrator, the director of the legislative service bureau
- 7 DEPARTMENT OF HISTORY, ARTS, AND LIBRARIES, the state librarian,

1 and certain state officials and agencies; and to repeal acts and

- 3 Sec. 2. As used in this act:
- 4 (a) "Board" means the board of trustees of the library cre-
- 5 ated in section 4.
- 6 (b) "Council" means the legislative council established
- 7 under section 15 of article IV of the state constitution of
- **8** <del>1963.</del>
- 9 (c) "Council administrator" means that term as defined in
- 10 section 102 of the legislative council act, Act No. 268 of the
- 11 Public Acts of 1986, being section 4.1102 of the Michigan
- 12 Compiled Laws.
- 13 (B) "DEPARTMENT" MEANS THE DEPARTMENT OF HISTORY, ARTS, AND
- 14 LIBRARIES.
- 15 (C)  $\frac{\text{(d)}}{\text{(d)}}$  "Library" means the library of Michigan.
- 16 (D) "RULE" MEANS A RULE PROMULGATED PURSUANT TO THE ADMINIS-
- 17 TRATIVE PROCEDURES ACT OF 1969, 1969 PA 306, MCL 24.201 TO
- **18** 24.328.
- 19 Sec. 3. The library of Michigan is created within the
- 20 legislative council DEPARTMENT.
- 21 Sec. 4. (1) A board of trustees of the library is created
- 22 within the legislative branch of state government DEPARTMENT.
- 23 The board shall make budget recommendations to the council to be
- 24 submitted to the house and senate appropriations committees as
- 25 part of the total budget recommendations for the legislative
- 26 council, and shall make recommendations to the council
- 27 DEPARTMENT on the following matters:

- 1 (a) The services the library shall provide.
- 2 (b) The manner in which the services shall be provided.
- 3 (c) Other matters of general policy concerning the library.

- 4 (D) THE BUDGET FOR THE LIBRARY.
- 5 (E) PROPOSED RULES GOVERNING OPERATIONS OF THE LIBRARY.
- 6 (2) The board shall meet not less than 3 times per year,
- 7 including a meeting to be held in January of each year. The
- 8 board shall meet also at the call of the chairperson of the
- 9 board.
- 10 (3) The board shall consist of the following:
- 11 (a) Four legislators appointed by the council, 1 from the
- 12 majority party and 1 from the minority party in each house.
- 13 (A) ONE MEMBER APPOINTED BY THE SPEAKER OF THE HOUSE OF
- 14 REPRESENTATIVES.
- 15 (B) ONE MEMBER APPOINTED BY THE HOUSE OF REPRESENTATIVES
- 16 MINORITY LEADER.
- 17 (C) ONE MEMBER APPOINTED BY THE SENATE MAJORITY LEADER.
- 18 (D) ONE MEMBER APPOINTED BY THE SENATE MINORITY LEADER.
- 19 (E) THE DIRECTOR OF THE DEPARTMENT OR HIS OR HER DESIGNEE.
- **20** (F)  $\frac{\text{(b)}}{\text{(b)}}$  A representative of the Michigan library
- 21 association, to be appointed by the governor from a list of 3
- 22 persons nominated by the Michigan library association.
- 23 (G)  $\frac{(c)}{(c)}$  Two members of the general public who represent
- 24 users of the state library, to be appointed by the governor.
- 25 (H)  $\frac{\text{(d)}}{\text{(d)}}$  One member who is a librarian from a college or
- 26 university library, to be appointed by the governor.

- 1 (I)  $\frac{\text{(e)}}{\text{(e)}}$  One member who is a librarian from a public or

- 1 Sec. 5. The <del>council</del> GOVERNOR, in consultation with the
- 2 board, shall appoint a state librarian who shall serve at the
- 3 pleasure of the <del>council</del> GOVERNOR.
- 4 Sec. 6. (1) The state librarian shall have care and charge
- 5 of the library AND the administrative functions of the
- 6 library. -, and all budgeting functions of the library. The
- 7 council administrator DIRECTOR OF THE DEPARTMENT and THE state
- 8 librarian shall coordinate the activities of the library with the
- 9 legislative council DEPARTMENT.
- 10 (2) The state librarian shall be a graduate with a master's
- 11 degree in library science and shall have not less than 4 years'
- 12 experience in library work in an administrative capacity. Each
- 13 assistant state librarian shall be a graduate with a master's
- 14 degree in library science.
- Sec. 7. (1) The <del>council</del> DEPARTMENT, after consultation
- 16 with the board, may permit the state librarian to employ other
- 17 administrative and general assistants and employees as are neces-
- 18 sary for the care and management of the library, including the
- 19 law library branch of the library. Employment shall be offered
- 20 first to those persons who are employed by the state library on
- 21 March 30, 1983. No library employee shall convert for personal
- 22 or partisan use, unrelated to library business, any supplies,
- 23 services, facilities or staff provided by the state. -of
- 24 Michigan. Nor may a library employee be required to work during
- 25 paid or unpaid time to affect the result of an election.
- 26 (2) [FULL-TIME EQUATED POSITIONS] OF THE LIBRARY ON THE EFFECTIVE DATE OF THE
- 27 AMENDATORY ACT THAT ADDED THIS SUBSECTION SHALL BE TRANSFERRED TO

- 2 RULES AND SHALL BE ASSUMED INTO THE CLASSIFIED SERVICE.
- 3 Sec. 10. (1) The library shall maintain a complete collec-
- 4 tion of the public documents deposited under section 9 as a per-
- 5 manent reference file. The library is charged primarily with
- 6 providing reference services to the legislative branch of state
- 7 government and, in addition, shall provide those services to the
- 8 executive and judicial branches of state government and the gen-
- 9 eral public. The law library branch is charged primarily with
- 10 providing reference services to the legislative, executive, and
- 11 judicial branches of state government.
- 12 (2) The library shall deposit copies of each public document
- 13 deposited under section 9 in each designated depository library.
- 14 The depository libraries shall be designated by the state
- 15 librarian. The state librarian shall designate only those
- 16 libraries which will keep the documents readily accessible for
- 17 use and which will render assistance for the use of the documents
- 18 without charge.
- 19 (3) The library also shall DO ALL OF THE FOLLOWING:
- 20 (a) Send 1 copy of each public document deposited under sec-
- 21 tion 9 to the library of congress.
- (b) Prepare and issue quarterly, a complete list of public
- 23 documents deposited under section 9 during the immediately pre-
- 24 ceding quarter. The lists shall be cumulated and printed at the
- 25 end of each calender year. A copy shall be distributed by the
- 26 library to state departments, legislators, and to public and
- 27 college libraries within the state.

1 (c) Establish a document exchange system with agencies in

- 2 other states to make available selected documents published by
- 3 other states for use by the people of this state.
- 4 (d) Exchange the judicial decisions, statutes, journals,
- 5 legislative and executive documents of this state, and other
- 6 books placed in the care of the library for the purpose of
- 7 exchange with the libraries of other states, the government of
- 8 the United States, foreign countries, and societies and
- 9 institutions.
- 10 (e) Sell or exchange duplicate volumes or sets of works not
- 11 needed for use in the library and apply the proceeds to the pur-
- 12 chase of other books for the library.
- 13 (f) Further, by all appropriate means, the development of
- 14 effective, statewide school library services.
- 15 (g) Encourage contractual and cooperative arrangements
- 16 between and among all kinds of libraries for the improvement of
- 17 library services to the people of this state.
- 18 (h) Coordinate the library's library services with the
- 19 library services of all kinds of libraries.
- 20 (i) Collect, preserve, and publish appropriate statistics on
- 21 all kinds of libraries in the state.
- 22 (j) Conduct research and publish the results for the benefit
- 23 of all kinds of libraries and the library services to the people
- 24 of the state.
- 25 (k) Provide all services which the state library was autho-
- 26 rized to provide immediately preceding the effective date of
- 27 this act MARCH 30, 1983.

- (l) Under the authority granted by law, promote and advance
- 2 library science in this state.
  - [(4) THE LEGISLATIVE COUNCIL SHALL MAINTAIN A WEBSITE CONTAINING INFORMATION, DOCUMENTS, AND OTHER DATA GENERATED BY THE LEGISLATURE OR A LEGISLATIVE COUNCIL AGENCY. THE LIBRARY SHALL PROVIDE COPIES TO THE LEGISLATIVE COUNCIL ANY DOCUMENTS OR INFORMATION IN THE POSSESSION OF THE LIBRARY REQUESTED BY THE LEGISLATIVE COUNCIL THAT WILL ASSIST THE LEGISLATIVE COUNCIL IN CARRYING OUT ITS RESPONSIBILITIES UNDER THIS SUBSECTION.]
- 3 SEC. 10A. THE DEPARTMENT, IN CONSULTATION WITH THE BOARD,
- 4 MAY PROMULGATE RULES RELATED TO THE OPERATIONS OF THE LIBRARY.
- 5 Sec. 11. The state librarian shall report annually to the
- 6 -council GOVERNOR and to the legislature on the operations of
- 7 the library and on the progress made in automating the operations
- 8 of the library.
