

SUBSTITUTE FOR  
HOUSE BILL NO. 5271

A bill to amend 1968 PA 319, entitled

"An act to provide a uniform crime reporting system; to provide for the submitting of such report to the department of state police; to require submission of the report by certain police agencies; to require the reporting on wanted persons and stolen vehicles; to require the reporting of information regarding certain persons and unidentified bodies of deceased persons; to prescribe certain powers and duties of law enforcement agencies; and to vest the director of the department of state police with certain authority,"

by amending section 7 (MCL 28.257).

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1       Sec. 7. The chief of police of each city or village, the  
2 chief of police of each township having a police department, and  
3 the sheriff of each county within this state shall report to the  
4 department of state police, in a manner prescribed by the depart-  
5 ment, the following information related to ~~crimes of~~ domestic  
6 ~~assault~~ VIOLENCE INCIDENTS:

1 (a) The number of assaults reported ~~which~~ THAT involve an  
2 adult and a minor and the disposition of those offenses.

3 (b) The number of assaults reported ~~which~~ THAT involve  
4 EITHER 2 male adults or 2 female adults and the disposition of  
5 those offenses.

6 (c) The number of assaults reported ~~which~~ THAT involve 1  
7 male adult and 1 female adult and the disposition of those  
8 offenses.

9 (d) The number of ~~assaults~~ CRIMES reported ~~which~~ THAT  
10 involve ~~a person and his or her spouse~~ AN INDIVIDUAL AND HIS OR  
11 HER SPOUSE, HIS OR HER FORMER SPOUSE, AN INDIVIDUAL WITH WHOM HE  
12 OR SHE HAS HAD A CHILD IN COMMON, AN INDIVIDUAL WITH WHOM HE OR  
13 SHE HAS OR HAS HAD A DATING RELATIONSHIP, OR AN INDIVIDUAL WHO  
14 RESIDES OR HAS RESIDED IN THE SAME HOUSEHOLD; and the disposition  
15 of those offenses. AS USED IN THIS SUBDIVISION, "DATING  
16 RELATIONSHIP" MEANS THAT TERM AS DEFINED IN SECTION 2950 OF THE  
17 REVISED JUDICATURE ACT OF 1961, 1961 PA 236, MCL 600.2950.

18 (e) Other statistics the director of the department of state  
19 police considers necessary to obtain accurate and reliable data  
20 on the incidence of domestic ~~assault~~ VIOLENCE in this state.

21 Enacting section 1. This amendatory act takes effect  
22 October 1, 2002.
