# SUBSTITUTE FOR HOUSE BILL NO. 5280

## A bill to amend 1978 PA 389, entitled

"An act to provide for the prevention and treatment of domestic violence; to develop and establish policies, procedures, and standards for providing domestic violence assistance programs and services; to create a domestic violence prevention and treatment board and prescribe its powers and duties; to establish a domestic violence prevention and treatment fund and provide for its use; and to prescribe powers and duties of the family independence agency,"

(MCL 400.1501 to 400.1511) by adding section 11.

#### THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 11. (1) THE STATE OR A COUNTY MAY ESTABLISH AN INTER-
- 2 AGENCY DOMESTIC VIOLENCE FATALITY REVIEW TEAM. TWO OR MORE COUN-
- 3 TIES MAY ESTABLISH A SINGLE DOMESTIC VIOLENCE FATALITY REVIEW
- 4 TEAM FOR THOSE COUNTIES. THE FATALITY REVIEW TEAMS MAY REVIEW
- 5 FATAL AND NEAR-FATAL INCIDENTS OF DOMESTIC VIOLENCE, INCLUDING
- 6 SUICIDES. THE REVIEW MAY INCLUDE A REVIEW OF EVENTS LEADING UP
- 7 TO THE DOMESTIC VIOLENCE INCIDENT, AVAILABLE COMMUNITY RESOURCES,

- 12 FOR USE BY STATE, COUNTY, AND MULTICOUNTY DOMESTIC VIOLENCE
- 13 FATALITY REVIEW TEAMS, MAY DEVELOP A FORM FOR USE BY FATALITY
- 14 REVIEW TEAMS TO REPORT ANNUAL AGGREGATE FINDINGS AND RECOMMENDA-

[Enacting section 1. This amendatory act takes effect April 1,
