- 14 (v) Whether and how many times the suspect physically
- 15 assaulted the victim and a description of any weapon or object

- 17 (vi) A description of all injuries sustained by the victim
- 18 and an explanation of how the injuries were sustained.
- 19 (vii) If the victim sought medical attention, information
- 20 concerning where and how the victim was transported, whether the
- 21 victim was admitted to a hospital or clinic for treatment, and
- 22 the name and telephone number of the attending physician.
- 23 (viii) A description of any property damage reported by the
- 24 victim or evident at the scene.
- 25 (f) A description of any previous domestic violence inci-
- 26 dents between the victim and the suspect.
