## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1       Sec. 124. (1) This act does not modify the requirements of  
2 the following:

11 listed in subsection (1) shall comply with those acts and shall  
12 comply with this act. If there is any inconsistency between  
13 those acts and this act, those acts shall control.
