# SENATE SUBSTITUTE FOR HOUSE BILL NO. 4258

A bill to make appropriations for the state institutions of higher education and certain state purposes related to education for the fiscal year ending September 30, 2002; to provide for the expenditures of those appropriations; and to prescribe the powers and duties of certain state departments, institutions, agencies, employees, and officers.

7	Sec. 201. Pursuant to section 30 of article IX of the state consti-
8	tution of 1963, total state spending from state resources under part 1
9	for fiscal year 2001-2002 is \$2,016,266,015.00 and state spending from
10	state resources to be paid to local units of government for fiscal year
11	2001-2002 is \$4,050,073.00. The itemized statement below identifies
12	appropriations from which spending to units of local government will
13	occur:

18	Sec. 202. The appropriations authorized under this act are subject
19	to the management and budget act, 1984 PA 431, MCL 18.1101 to 18.1594.
20	Sec. 208. Unless otherwise specified, the institutions of higher
21	education shall use the Internet to fulfill the reporting requirements of
22	this act. This may include transmission of reports via electronic mail
23	to the recipients identified for each reporting requirement, or it may
24	include placement of reports on an Internet or Intranet site. Quarterly,
25	the institutions of higher education shall provide to the appropriations
26	subcommittee members, state budget office, and the fiscal agencies an
27	electronic and paper copy listing of the reports submitted during the

- 3 Sec. 209. Funds appropriated in part 1 shall not be used for the
- 4 purchase of foreign goods or services, or both, if competitively priced
- 5 and of comparable quality American goods and services, or both, are
- 6 available. Not later than May 1, 2002, each university shall have avail-
- 7 able upon request information on efforts to comply with this section.
- 8 Sec. 210. (1) The funds appropriated in part 1 to state institu-
- 9 tions of higher education shall be paid out of the state treasury and
- 10 distributed by the state treasurer to the respective institutions in 11
- 11 equal monthly installments on the sixteenth of each month, or the next
- 12 succeeding business day, beginning with October 16, 2001. Except for
- 13 Wayne State University, each institution shall accrue its July and August
- 14 2002 payments to its institutional fiscal year ending June 30, 2002.
- 15 (2) The amount distributed to an institution shall not exceed the
- 16 net appropriations plus additional distributions specifically authorized
- 17 by this act.
- 18 (3) All universities shall submit higher education institutional
- 19 data inventory (HEIDI) data and associated financial and program informa-
- 20 tion requested by and in a manner prescribed by the state budget
- 21 director. For universities with fiscal years ending June 30, 2001, these
- 22 data shall be submitted to the state budget director by October 15,
- 23 2001. Universities with a fiscal year ending September 30, 2001 shall
- 24 submit preliminary HEIDI data by November 15, 2001 and final data by
- 25 December 15, 2001. If a university fails to submit HEIDI data and asso-
- 26 ciated financial aid program information in accordance with this

- 3 (4) A detailed description of procedures utilized to arrive at the
- 4 amounts appropriated in part 1 shall be submitted to each institution by
- 5 the senate and house fiscal agencies.
- 6 Sec. 211. Funds received by the state from the federal government
- 7 or private sources for the use of a college or university are appropri-
- 8 ated for the purposes for which they are provided. The acceptance and
- 9 use of federal or private funds does not place an obligation upon the
- 10 legislature to continue the purposes for which the funds are made
- 11 available.
- 12 Sec. 213. A state institution of higher education that receives
- 13 funds under this act shall furnish all program and financial information
- 14 that is required by and in a manner prescribed by the state budget direc-
- 15 tor or the house or senate appropriations committee.
- 16 Sec. 215. All funds received under part 1 for the charter schools
- 17 development and performance institute are intended to be expended on
- 18 activities of that institute.
- 19 Sec. 216. By February 15, 2002, the department of treasury shall
- 20 provide the state budget director, the subcommittees on higher education
- 21 of the house and senate appropriations committees, and the senate and
- 22 house fiscal agencies with an annual report on restricted fund balances,
- 23 projected revenues, and expenditures for the fiscal years ending

#### 1 GRANTS AND FINANCIAL AID

- 2 Sec. 301. (1) Payments of the amounts included in part 1 for the
- 3 state competitive scholarship program shall be distributed pursuant to
- 4 1964 PA 208, MCL 390.971 to 390.981.
- 5 (2) The Michigan higher education assistance authority shall imple-
- 6 ment a proportional competitive scholarship maximum award level for
- 7 recipients enrolled less than full-time in a given semester or term.
- 8 (3) If a student who receives an award under this section has his or
- 9 her tuition and fees paid under the Michigan educational trust program,
- 10 pursuant to the Michigan education trust act, 1986 PA 316, MCL 390.1421
- 11 to 390.1444, and still has financial need, the funds awarded under this
- 12 section may be used for educational expenses other than tuition and
- 13 fees.
- 14 (4) If the Michigan higher education assistance authority increases
- 15 the maximum award per eligible student from that provided in the previous
- 16 fiscal year, it shall not have the effect of reducing the number of eli-
- 17 gible students receiving awards in relation to the total number of eligi-
- 18 ble applicants. Any increase in the maximum grant shall be proportional
- 19 for all eligible students receiving awards.
- 20 Sec. 302. (1) The amounts appropriated in part 1 for the state
- 21 tuition grant program shall be distributed pursuant to 1966 PA 313,
- 22 MCL 390.991 to 390.997a.
- 23 (2) Tuition grant awards shall be made to all eligible Michigan res-
- 24 idents who apply before September 1, 2001 and who are qualified. Tuition
- 25 grant awards shall not be made to students newly enrolled in a juris
- 26 doctor law degree program after the 1995-96 academic year.

- 1 (3) The Michigan higher education assistance authority shall
- 2 determine an actual maximum tuition grant award per student that ensures
- 3 that the aggregate payments for the tuition grant program do not exceed
- 4 the appropriation contained in part 1 for the state tuition grant
- 5 program. By December 15, 2001, and again by February 1, 2002, the
- 6 authority shall analyze the status of award commitments, shall make any
- 7 necessary adjustments, and shall confirm that those award commitments
- 8 will not exceed the appropriation contained in part 1 for the tuition
- 9 grant program. The determination and actions shall be reported to the
- 10 state budget director and the house and senate fiscal agencies no later
- 11 than February 15, 2002. If award adjustments are necessary, the students
- 12 shall be notified of the adjustment by the third Monday in February.
- 13 (4) Any unexpended and unencumbered funds remaining on September 30,
- 14 2002 from the amounts appropriated in part 1 for the tuition grant pro-
- 15 gram shall not lapse on September 30, 2002, but shall continue to be
- 16 available for expenditure for tuition grants provided in the 2002-2003
- 17 fiscal year. The use of these unexpended fiscal year 2001-2002 funds
- 18 shall terminate at the end of the 2002-2003 fiscal year.
- 19 (5) The Michigan higher education assistance authority shall con-
- 20 tinue a proportional tuition grant maximum award level for recipients
- 21 enrolled less than full-time in a given semester or term.
- 22 (6) If the Michigan higher education assistance authority increases
- 23 the maximum award per eligible student from that provided in the previous
- 24 fiscal year, it shall not have the effect of reducing the number of eli-
- 25 gible students receiving awards in relation to the total number of eligi-
- 26 ble applicants. Any increase in the maximum grant shall be proportional
- 27 for all eligible students receiving awards for fiscal year 2001-2002.

- 1 (7) All Ferris State University students enrolled at Kendall College
- 2 of Art and Design prior to January 1, 2001 who were qualified for the

- 3 state tuition grant shall continue to receive the dollar amount of the
- 4 state tuition grant for which they were eligible until they graduate or
- 5 are no longer enrolled at Ferris State University.
- 6 Sec. 303. (1) Included in the appropriation in part 1 is funding
- 7 for the Michigan work-study program established under 1986 PA 288,
- 8 MCL 390.1371 to 390.1382, and 1986 PA 303, MCL 390.1321 to 390.1332. An
- 9 effort should be made by each institution participating in the Michigan
- 10 work-study program to assure that not less than 10% of those undergradu-
- 11 ate, graduate, and professional students eligible to participate in the
- 12 program are placed with for-profit employers no later than December 31 of
- 13 each year for which funding is provided under this act.
- 14 (2) The Michigan higher education assistance authority shall allo-
- 15 cate funds to institutions eligible for work-study money based upon each
- 16 institution's specific Pell grant index and each institution's utiliza-
- 17 tion rate of work-study funds for the 3 most recent years for which sta-
- 18 tistics are available.
- 19 (3) The Michigan higher education assistance authority shall set
- 20 aside not more than 5% of the total work-study appropriation to process
- 21 requests from participating institutions for allocation adjustments.
- 22 Allocation adjustments shall be based on criteria set by the authority
- 23 prior to making the allocations under subsection (2).
- 24 Sec. 304. (1) Payments of the amounts included in part 1 for the
- 25 general degree reimbursement program established under 1974 PA 75,
- 26 MCL 390.1021 to 390.1027, shall be made for all degrees identified in
- 27 section 1(1) of 1974 PA 75, MCL 390.1021, except doctor of dental

1 surgery, doctor of dental medicine, juris doctor law, and allied health

- 3 (2) The reimbursement rate per eligible degree shall be the equally
- 4 prorated amount permitted by the appropriation, except that the amount of

- 6 reimbursement for the other degrees eligible under subsection (1) for the
- 7 general degree reimbursement program.
- 8 (3) From the general degree reimbursement program, \$135,300.00 shall
- 9 be provided to Spring Arbor College for the southern Michigan state
- 10 prison program.
- 11 (4) From the general degree reimbursement program, \$200,500.00 shall
- 12 be provided to the University of Detroit Mercy for graduate research
- **13** aid.
- 14 (5) From the general degree reimbursement program, \$30,100.00 shall

- 16 (6) From the general degree reimbursement program, \$50,000.00 shall

- 18 Sec. 305. The reimbursement rate per eligible degree under the
- 19 allied health degree reimbursement program established under 1974 PA 75,
- 20 MCL 390.1021 to 390.1027, shall be the equally prorated amount permitted
- 21 by the appropriation included in part 1.
- 22 Sec. 306. Funds disbursed through the degree reimbursement programs
- 23 shall not be used by any recipient institution for theology or divinity
- 24 programs.
- 25 Sec. 307. The auditor general may audit selected enrollments,
- 26 degrees, and awards at selected independent colleges and universities
- 27 receiving awards administered by the department of treasury. The audits

1 shall be based upon definitions and requirements established by the

- 24 (d) For the general degree reimbursement program, allied health
- 25 degree reimbursement program, Michigan resident dental grant program, and
- 26 Robert C. Byrd honors scholarship program, 50% shall be paid at the
- 27 beginning of the state's first fiscal quarter and 50% at the beginning of

- 2 conferred and total amounts to be paid are certified.
- 3 Sec. 309. The Michigan higher education assistance authority shall
- 4 determine the needs analysis criteria for students to qualify for the
- 5 competitive scholarship program and tuition grant program. To be consis-
- 6 tent with federal requirements, student wages may be taken into consider-
- 7 ation when determining the amount of the award.
- 8 Sec. 310. (1) The funds appropriated in part 1 for the tuition
- 9 incentive program/high school completion program shall be distributed as
- 10 provided in this section and pursuant to the administrative procedures
- 11 for the tuition incentive program/high school completion program of the
- 12 department of treasury.
- 13 (2) As used in this section:
- 14 (a) "Phase I" means the first part of the tuition incentive assist-
- 15 ance program defined as the academic period of 80 semester or 120 term
- 16 credits, or less, leading to an associate degree or certificate.
- 17 (b) "Phase II" means the second part of the tuition incentive
- 18 assistance program which provides assistance in the third and fourth year
- 19 of 4-year degree programs.
- (c) "Department" means the department of treasury.
- 21 (3) A person shall meet the following basic criteria and financial
- 22 thresholds to be eligible for tuition incentive benefits:
- (a) To be eligible for phase I, a person shall meet all of the fol-
- 24 lowing criteria:
- 25 (i) Apply for certification to the department before graduating from
- 26 high school or completing the general education development (GED)
- 27 certificate.

- 1 (ii) Be less than 20 years of age at the time of high school
- 2 graduation or GED completion.
- 3 (iii) Be a United States citizen and a resident of Michigan accord-
- 4 ing to institutional criteria.
- 5 (iv) Be at least a half-time student, earning less than 80 semester
- 6 or 120 term credits at a participating educational institution within 4
- 7 years of high school graduation or GED certificate completion.
- 8 (b) To be eligible for phase II, a person shall meet either of the
- 9 following criteria in addition to the criteria in subdivision (a):
- 10 (i) Complete at least 56 transferable semester or 84 transferable
- 11 term credits.
- 12 (ii) Obtain an associate degree or certificate at a participating
- 13 institution.
- 14 (c) To be eligible for phase I or phase II, a person must be finan-
- 15 cially eligible as determined by the department. A person is financially
- 16 eligible for the tuition incentive program if that person was Medicaid
- 17 eligible for 24 months within the 36 months before application.
- 18 Certification of eligibility may begin in the sixth grade and continue
- 19 until the time of enrollment in a participating institution.
- 20 (4) For phase I, the department shall provide payment on behalf of a
- 21 person eligible under subsection (3). The department shall reject bill-
- 22 ings that are excessive or outside the guidelines for the type of educa-
- 23 tional institution.
- 24 (5) For phase I, all of the following apply:
- 25 (a) Payments for associate degree or certificate programs shall not
- 26 be made for more than 80 semester or 120 term credits for any individual
- 27 student at any participating institution.

- 18 1 (b) For persons enrolled at a Michigan community college, the
- 2 department shall pay the current in-district tuition and mandatory fees.
- 3 For persons residing in an area that is not included in any community
- 4 college district, the out-of-district tuition rate may be authorized.
- 5 (c) For persons enrolled at a Michigan public university, the
- 6 department shall pay lower level resident tuition and mandatory fees for
- 7 the current year.
- 8 (d) For persons enrolled at a Michigan independent, nonprofit degree
- 9 granting college or university, or a Michigan federal tribally controlled
- 10 community college, or Focus: HOPE, the department shall pay mandatory
- 11 fees for the current year and a per credit payment that does not exceed
- 12 the average community college in-district per credit tuition rate as
- 13 reported on August 1, for the immediately preceding academic year.
