(As passed the House, March 12, 2002)

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding part 172.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 PART 172. MERCURY THERMOMETERS
- 2 SEC. 17201. AS USED IN THIS PART:
- 3 (A) "MANUFACTURER" MEANS A PERSON THAT PRODUCES, IMPORTS, OR
- 4 DISTRIBUTES MERCURY THERMOMETERS IN THIS STATE.
- 5 (B) "MERCURY FEVER THERMOMETER" MEANS A MERCURY THERMOMETER
- 6 USED FOR MEASURING BODY TEMPERATURE.
- 7 (C) "MERCURY THERMOMETER" MEANS A PRODUCT OR COMPONENT,
- 8 OTHER THAN A DRY CELL BATTERY, OF A PRODUCT USED FOR MEASURING
- 9 TEMPERATURE THAT CONTAINS MERCURY OR A MERCURY COMPOUND
- 10 INTENTIONALLY ADDED TO THE PRODUCT OR COMPONENT.

- (B) PHARMACEUTICAL RESEARCH PURPOSES.(2) BEGINNING ON JANUARY 1, 2003, A PERSON SHALL NOT SELL, 8
- 9 OFFER FOR SALE, OR OFFER FOR PROMOTIONAL PURPOSES A MERCURY FEVER
- 10 THERMOMETER IN THIS STATE OR FOR USE IN THIS STATE, EXCEPT BY
- 11 PRESCRIPTION. A MANUFACTURER OF MERCURY FEVER THERMOMETERS SHALL
- 12 SUPPLY CLEAR INSTRUCTIONS ON THE CAREFUL HANDLING OF THE THERMOM-

- 16 SHALL ENFORCE THIS PART.
- (2) A PERSON WHO VIOLATES THIS PART IS GUILTY OF A MISDE-17
- 18 MEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 60 DAYS OR A
- 19 FINE OF NOT MORE THAN \$1,000.00, OR BOTH, PLUS THE COSTS OF
- 20 PROSECUTION.
