

HOUSE BILL No. 4776

May 15, 2001, Introduced by Reps. Vear, Plakas, Bernero, Pappageorge, Birkholz and Tabor and referred to the Committee on Senior Health, Security and Retirement.

A bill to amend 1978 PA 368, entitled
"Public health code,"
by amending sections 16131, 16263, and 21720 (MCL 333.16131,
333.16263, and 333.21720), sections 16131 and 16263 as amended by
2000 PA 11, and by adding section 16328 and part 173; and to
repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 16131. The terms of office of individual members of
2 the boards and task forces, except those appointed to fill vacan-
3 cies, expire 4 years after appointment as follows:

24 degree as an orthopedic physician's assistant before January 1,
25 1977, may use the title "orthopedic physician's assistant"
26 whether or not the person is licensed under this article.

16 (B) "NURSING HOME ADMINISTRATOR" MEANS THE INDIVIDUAL
17 LICENSED UNDER THIS ARTICLE TO ENGAGE IN THE PRACTICE OF NURSING
18 HOME ADMINISTRATION.

19 (C) "PRACTICE OF NURSING HOME ADMINISTRATION" MEANS PLAN-
20 NING, ORGANIZING, DIRECTING, AND CONTROLLING THE TOTAL OPERATION
