HOUSE BILL NO. 4955

(As passed the House, June 28, 2001)

A bill to amend 1984 PA 152, entitled
"Michigan iron industry museum advisory board act,"
by amending the title and sections 3 and 4 (MCL 399.73 and
399.74), the title and section 3 as amended by 1990 PA 232.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 TITLE

2 An act to create the Michigan iron industry museum advisory
3 board within the department of ~~state~~ HISTORY, ARTS, AND
4 LIBRARIES; and to prescribe its powers and duties.

5 Sec. 3. (1) The Michigan iron industry museum advisory
6 board is created within the department of ~~state~~ HISTORY, ARTS,
7 AND LIBRARIES.

8 (2) The advisory board shall consist of ~~9~~ THE FOLLOWING
9 MEMBERS:

1 (A) ONE MEMBER APPOINTED BY THE SPEAKER OF THE HOUSE OF
2 REPRESENTATIVES.

3 (B) ONE MEMBER APPOINTED BY THE SENATE MAJORITY LEADER.

4 (C) NINE members appointed by the governor, including all of
5 the following:

6 (i) ~~-(a)-~~ One representative from the city of Negaunee and 1
7 representative from the city of Marquette.

8 (ii) ~~-(b)-~~ One representative from the township of
9 Negaunee.

10 (iii) ~~-(c)-~~ One representative from the county board of com-
11 missioners of the county of Marquette.

12 (iv) ~~-(d)-~~ One representative from the county historical
13 society of the county of Marquette.

14 (v) ~~-(e)-~~ One representative from the mineral industry.

15 (vi) ~~-(f)-~~ Three members from the general citizenry of the
16 state, at least 1 of whom is a resident of the Upper Peninsula.

17 (3) Each member OF THE ADVISORY BOARD shall be a registered
18 voter and a resident of this state.

19 (4) Not more than ~~-5-~~ 6 members OF THE ADVISORY BOARD shall
20 be of the same political party at any 1 time.

21 (5) Except for members first appointed, the term of office
22 of each member OF THE ADVISORY BOARD APPOINTED UNDER

23 SUBSECTION (2)(C) shall be 4 years. Of the members OF THE
24 ADVISORY BOARD first appointed under subsection ~~-(2)-~~ (2)(C), 3

25 shall serve for 4 years, 3 shall serve for 3 years, and 3 shall
26 serve for 2 years. A MEMBER OF THE ADVISORY BOARD APPOINTED BY

1 MAJORITY LEADER UNDER SUBSECTION (2)(A) OR (B), RESPECTIVELY,
2 SHALL HOLD OFFICE FOR A TERM OF 2 YEARS TO COINCIDE WITH THE TERM
3 OF OFFICE OF STATE REPRESENTATIVE. Vacancies on the advisory
4 board shall be filled in the same manner as the original appoint-
5 ment for the remainder of the unexpired term.

6 (6) A member OF THE ADVISORY BOARD shall not receive any
7 compensation for his or her services, ~~as a member of the~~
8 ~~advisory board,~~ except for expenses incurred while acting as an
9 official representative of the advisory board. However, a member
10 of the advisory board shall not receive more than \$75.00 per day
11 for not more than 24 days per calendar year, for not more than 2
12 calendar years. All claims for expenses shall be paid pursuant
13 to voucher submitted to the department of treasury.

14 (7) The members OF THE ADVISORY BOARD annually shall elect a
15 chairperson, vice-chairperson, and secretary.

16 (8) The advisory board shall meet not less than twice each
17 calendar year ~~on~~ AT THE call of the chairperson. A majority of
18 the members OF THE ADVISORY BOARD shall constitute a quorum for
19 the transaction of business.

20 Sec. 4. The advisory board shall do all of the following:

21 (a) Advise the department of ~~state~~ HISTORY, ARTS, AND
22 LIBRARIES as to construction of, and policies, plans, and pro-
23 grams concerning the museum site.

24 (b) Facilitate cooperation between the department of ~~state~~
25 HISTORY, ARTS, AND LIBRARIES and public and private entities
26 interested in historic preservation at the museum site.

1 (c) Encourage donations of real and personal property to the
2 ~~secretary of state~~ DEPARTMENT OF HISTORY, ARTS, AND LIBRARIES
3 for purposes incidental to, or connected with, the museum site,
4 including artifacts associated with the museum site.

5 (d) Promote public use of the museum site.

6 Enacting section 1. This amendatory act does not take
7 effect unless House Bill No. 4941 of the 91st Legislature is
8 enacted into law.
