HOUSE BILL NO. 4957

(As passed the House, June 28, 2001)

A bill to amend 1998 PA 409, entitled "Michigan freedom trail commission act," by amending sections 2 and 3 (MCL 399.82 and 399.83).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. As used in this act:
- 2 (a) "Department" means the department of state HISTORY,
- 3 ARTS, AND LIBRARIES.
- 4 (b) "Michigan freedom trail commission" or "commission"
- 5 means the Michigan freedom trail commission created in
- 6 section 3.
- 7 Sec. 3. (1) The Michigan freedom trail commission is cre-
- 8 ated within the department. of state. The commission shall
- 9 exercise its prescribed duties and functions independently of the
- 10 secretary of state. However, the THE budgeting, procurement,
- 11 and related functions of the commission and administrative

- 1 responsibilities for the staff of the commission shall be
- 2 performed under the direction and supervision of the secretary

- 4 (2) The commission shall consist of the following MEMBERS:
- 5 (A) ONE MEMBER APPOINTED BY THE SPEAKER OF THE HOUSE OF
- 6 REPRESENTATIVES.
- 7 (B) ONE MEMBER APPOINTED BY THE SENATE MAJORITY LEADER.
- 8 (C) (a) Members NINE MEMBERS appointed by the governor, as
- 9 follows:
- 10 (i) Three members from the academic community knowledgeable
- 11 in African-American history.
- (ii) One member actively involved in civil rights issues.
- 13 (iii) One member knowledgeable in historic preservation.
- 14 (iv) One member representing local communities in which the
- 15 underground railroad had a significant presence.
- 16 (v) Three members at large, 1 of whom shall be a representa-
- 17 tive of the museum of African American history located in the
- 18 city of Detroit.
- 19 (D) (b) Members THREE MEMBERS serving ex officio without
- 20 vote as follows:
- 22 commission ECONOMIC DEVELOPMENT CORPORATION or his or her
- 23 representative.
- 24 (ii) The state librarian or his or her representative.
- 25 (iii) The secretary of state DIRECTOR OF THE DEPARTMENT or
- 26 his or her representative.

1 (3) The members appointed under subsection $\frac{(2)(a)}{(2)(C)}$

- 2 first appointed to the commission shall be appointed within 90
- 3 days after the effective date of this act DECEMBER 21, 1998.
- 4 (4) Members of the commission appointed under subsection
- 5 (2)(a) (2)(C) shall serve for terms of 4 years or until a suc-
- 6 cessor is appointed, whichever is later, except that of the mem-
- 7 bers first appointed 3 shall serve for 1 year, 3 shall serve for

- 13 (5) If a A vacancy occurs on the commission among mem-
- 14 bers appointed under subsection (2)(a), the governor shall make
- 15 an appointment SHALL BE FILLED for the unexpired term in the
- 16 same manner as the original appointment.
- 17 (6) The governor, SPEAKER OF THE HOUSE OF REPRESENTATIVES,
- 18 OR SENATE MAJORITY LEADER may remove a member of the commission
- 19 APPOINTED BY HIM OR HER for incompetency, dereliction of duty,
- 20 malfeasance, misfeasance, or nonfeasance in office, or any other
- 21 good cause.
- 22 (7) At the first meeting, the commission shall elect from
- 23 among its members a chairperson and other officers as it consid-
- 24 ers necessary or appropriate. After the first meeting, the com-
- 25 mission shall meet at least quarterly, or more frequently at the
- **26** call of the chairperson or if requested by -6 7 or more members
- 27 appointed under subsection (2)(a), (B), AND (C).

1 (8) A majority of the members of the commission appointed

- 2 under subsection (2)(a), (B), AND (C) constitute a quorum for the
- 3 transaction of business at a meeting of the commission. A major-
- 4 ity of the members appointed under subsection (2)(a), (B), AND
- 5 (C) present and serving are required for official action of the
- 6 commission.
- (9) The business that the commission may perform shall be
- 8 conducted at a public meeting of the commission held in compli-
- 9 ance with the open meetings act, 1976 PA 267, MCL 15.261 to
- **10** 15.275.
- (10) A writing prepared, owned, used, in the possession of, 11
- 12 or retained by the commission in the performance of an official
- 13 function is subject to the freedom of information act, 1976
- 14 PA 442, MCL 15.231 to 15.246.
- 15 (11) Members of the commission shall serve without
- 16 compensation. However, members of the commission may be reim-
- 17 bursed for their actual and necessary expenses incurred in the
- 18 performance of their official duties as members of the
- 19 commission.
- 20 Enacting section 1. This amendatory act does not take
- 21 effect unless House Bill No. 4941 of the 91st Legislature is
- 22 enacted into law.
