SENATE SUBSTITUTE FOR HOUSE BILL NO. 5280

A bill to amend 1978 PA 389, entitled

"An act to provide for the prevention and treatment of domestic violence; to develop and establish policies, procedures, and standards for providing domestic violence assistance programs and services; to create a domestic violence prevention and treatment board and prescribe its powers and duties; to establish a domestic violence prevention and treatment fund and provide for its use; and to prescribe powers and duties of the family independence agency,"

(MCL 400.1501 to 400.1510) by amending the title and by adding section 11.

- 13 (5) IF A STATE FATALITY REVIEW TEAM IS CONVENED, THE STATE
- 14 FATALITY REVIEW TEAM SHALL BE CONVENED BY THE MICHIGAN DOMESTIC
- 15 VIOLENCE PREVENTION AND TREATMENT BOARD.
- 16 (6) SUBJECT TO SUBSECTION (9), INFORMATION OBTAINED OR CRE-
- 17 ATED BY A FATALITY REVIEW TEAM IS CONFIDENTIAL AND NOT SUBJECT TO

- 15 VIOLENCE WHOSE CASE IS BEING REVIEWED, OR THAT PERSON'S FAMILY
- 16 MEMBERS, OR AN ALLEGED OR SUSPECTED PERPETRATOR OF ABUSE UPON THE
- 17 VICTIM, OR REGARDING THE INVOLVEMENT OF ANY AGENCY WITH THE
- 18 VICTIM OR THAT PERSON'S FAMILY, SHALL NOT BE DISCLOSED IN ANY

- 14 ING UNDERTAKEN OR PERFORMED WITHIN THE SCOPE OF THIS SECTION. IN
- 15 ADDITION, A PERSON ACTING AS A MEMBER OF A DOMESTIC VIOLENCE
- 16 FATALITY REVIEW TEAM OR ANY PERSON PROVIDING INFORMATION TO A
