HOUSE BILL NO. 5456

A bill to authorize the state administrative board to convey certain property in Jackson county; to prescribe conditions for the conveyance; and to provide for disposition of the revenue from the conveyance.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. The state administrative board, on behalf of the
- 2 state, may convey for consideration of not less than fair market
- 3 value as determined under section 3 certain state owned property
- 4 in Blackman charter township, Jackson county, Michigan, consist-
- 5 ing of 581.11 acres, of which 285.28 acres will be placed in a
- 6 wetland bank, and which is more particularly described as
- 7 follows:

- 17 ment, by a state survey or other legal description, as the state
- 18 administrative board or attorney general considers necessary.
- 19 Sec. 3. The fair market value of the property described in
- 20 section 1 shall be determined by an appraisal prepared by the
- 21 state tax commission or an independent fee appraiser.
- 22 Sec. 4. Any conveyance authorized under this act shall pro-
- 23 vide that the property is to be used by the grantee for an indus-
- 24 trial park with adjacent wetlands, in conjunction with the enter-
- 25 prise park proposed industrial development plan as presented to
- 26 the department of management and budget, the department of
- 27 corrections, Blackman charter township, and Leoni charter

- 4 Sec. 5. (1) Any sale of property authorized under this act
- 5 shall be conducted in a manner to realize the highest price for
- 6 the sale and the highest return to the state. The sale shall be
- 7 done in an open manner that uses 1 or more of the following:
- 8 (a) A competitive sealed bid.
- 9 (b) Oral bid.
- 10 (c) Public auction.
- (d) Use of broker services.
- 12 (2) Broker services for the sale shall only be used if there
- 13 are 3 or more bidders for this property. The minimum selling
- 14 price for the property shall be the higher value of either its
- 15 fair market value or the result of a professional concept plan
- 16 value as determined by a real estate professional qualified to
- 17 make such valuations. This real estate professional shall be
- 18 selected through a request for proposal and competitive bid
- 19 process.
- 20 (3) A notice of a sealed or oral bid, public auction sale,
- 21 or use of broker negotiation services, regarding the sale of
- 22 property under this act shall be published at least once in a
- 23 newspaper as defined in section 1461 of the revised judicature
- 24 act of 1961, 1961 PA 236, MCL 600.1461, not less than 10 days
- 25 before the sale. The newspaper shall be one that is published in
- 26 the county where the property is located. If a newspaper is not
- 27 published in the county where the property is located, the notice

- 1 shall be published in a newspaper in a county nearest to the
- county in which the property is located. The notice shall 2
- 3 describe the general location of the property and the date, time,
- and place of the sale. 4
- 5 Sec. 6. A conveyance authorized by this act shall be by
- quitclaim deed approved by the attorney general. To ensure the 6
- security and operations of the department of corrections and the 7
- state of Michigan, all final sales under this act shall be 8
- approved by the department of corrections and the department of 9
- management and budget. 10
- Sec. 7. The net revenue received under this act shall be 11
- deposited in the state treasury and credited to the general 12
- fund. As used in this section, "net revenue" means the proceeds 13
- 14 from the sale of the property less reimbursement for any costs to
- 15 the state associated with the sale of the property.
- Sec. 8. This act does not take effect unless all of the 16
- following bills of the 91st Legislature are enacted into law: 17
