HOUSE BILL NO. 5480

(As passed the House, February 14, 2002)

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"
(MCL 750.1 to 750.568) by adding section 297f.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 297F. (1) AS USED IN THIS SECTION, "HALAL" MEANS PRE-
- 2 PARED OR PROCESSED IN ACCORDANCE WITH ISLAMIC RELIGIOUS
- 3 REQUIREMENTS.
- 4 (2) A PERSON WHO, WITH INTENT TO DEFRAUD, DOES ANY OF THE
- 5 FOLLOWING IS GUILTY OF A MISDEMEANOR:
- 6 (A) SELLS OR EXPOSES FOR SALE IN ANY PLACE WHERE FOOD PRO-
- 7 DUCTS ARE SOLD FOR CONSUMMATION ON OR OFF THE PREMISES ANY MEAT,
- 8 MEAT PREPARATION, ARTICLE OF FOOD, OR FOOD PRODUCT, AND FALSELY
- 9 REPRESENTS IT TO BE HALAL, WHETHER THE MEAT, OR MEAT PREPARATION,
- 10 ARTICLE OF FOOD, OR FOOD PRODUCT IS RAW OR PREPARED FOR HUMAN
- 11 CONSUMPTION, EITHER BY DIRECT STATEMENT ORALLY, OR IN WRITING,

- 4 (B) FALSELY REPRESENTS ANY FOOD PRODUCT OR THE CONTENTS OF
- 5 ANY PACKAGE OR CONTAINER TO BE SO CONSTITUTED AND PREPARED, BY
- 6 HAVING OR PERMITTING TO BE INSCRIBED ON THE PACKAGE OR CONTAINER
- 7 THE WORD "HALAL" IN ENGLISH.
- 8 (C) EXPOSES FOR SALE IN ANY SHOW WINDOW OR PLACE OF BUSINESS
- 9 BOTH HALAL AND NONHALAL MEAT OR MEAT PREPARATIONS, OR HALAL AND
- 10 NONHALAL FOOD OR FOOD PRODUCTS, EITHER RAW OR PREPARED FOR HUMAN
- 11 CONSUMPTION, AND WHO FAILS TO IDENTIFY EACH KIND OF MEAT OR MEAT
- 12 PREPARATION AS "HALAL MEAT" OR "HALAL FOOD".
- 13 (D) DISPLAYS ON HIS OR HER WINDOW, DOOR, OR IN HIS OR HER
- 14 PLACE OF BUSINESS, OR IN HANDBILLS OR OTHER PRINTED MATTER DIS-
- 15 TRIBUTED INSIDE OR OUTSIDE OF HIS OR HER PLACE OF BUSINESS, WORDS
- 16 OR LETTERS IN ARABIC CHARACTERS OTHER THAN THE WORD "HALAL", OR
- 17 ANY SIGN, EMBLEM, INSIGNIA, SYMBOL, OR MARK IN SIMULATION OF
- 18 SAME, WITHOUT ALSO DISPLAYING IN ENGLISH LETTERS OF AT LEAST THE
- 19 SAME SIZE AS SUCH CHARACTERS, SIGNS, EMBLEMS, INSIGNIA, SYMBOLS,
- 20 OR MARKS, THE WORDS "WE SELL HALAL MEAT AND FOOD ONLY" OR "WE
- 21 SELL NONHALAL MEAT AND FOOD ONLY", OR "WE SELL BOTH HALAL AND
- 22 NONHALAL MEAT AND FOOD".
- 23 (3) POSSESSION OF NONHALAL FOOD, IN ANY PLACE OF BUSINESS
- 24 ADVERTISING THE SALE OF HALAL FOOD ONLY, IS PRESUMPTIVE EVIDENCE
- 25 THAT THE PERSON IN POSSESSION EXPOSES THE NONHALAL MEAT AND FOOD
- 26 FOR SALE WITH INTENT TO DEFRAUD.

- 1 (4) A PERSON WHO DOES ANY OF THE FOLLOWING IS GUILTY OF A
- 2 MISDEMEANOR:
- 3 (A) WILLFULLY MARKS, STAMPS, TAGS, BRANDS, LABELS, OR IN ANY
- 4 OTHER WAY OR BY ANY OTHER MEANS OF IDENTIFICATION REPRESENTS OR
- 5 CAUSES TO BE MARKED, STAMPED, TAGGED, BRANDED, LABELED, OR REPRE-
- 6 SENTED AS HALAL FOOD OR FOOD PRODUCTS NOT HALAL OR NOT SO
- 7 PREPARED.
- 8 (B) WILLFULLY REMOVES, DEFACES, OBLITERATES, COVERS, ALTERS,
- 9 OR DESTROYS, OR CAUSES TO BE REMOVED, DEFACED, OBLITERATED, COV-
- 10 ERED, ALTERED, OR DESTROYED THE ORIGINAL SLAUGHTERHOUSE PLUMBA OR
- 11 ANY OTHER MARK, STAMP, TAG, BRAND, LABEL, OR ANY OTHER MEANS OF
- 12 IDENTIFICATION AFFIXED TO FOODS OR FOOD PRODUCTS TO INDICATE THAT
- 13 THOSE FOODS OR FOOD PRODUCTS ARE HALAL.
- 14 (C) KNOWINGLY SELLS, DISPOSES OF, OR HAS IN HIS OR HER POS-
- 15 SESSION, FOR THE PURPOSE OF RESALE TO ANY PERSON AS HALAL, ANY
- 16 FOOD OR FOOD PRODUCTS NOT HAVING AFFIXED TO THE FOOD OR FOOD PRO-
- 17 DUCT THE ORIGINAL SLAUGHTERHOUSE PLUMBA OR ANY OTHER MARK, STAMP,
- 18 TAG, BRAND, LABEL, OR OTHER MEANS OF IDENTIFICATION EMPLOYED TO
- 19 INDICATE THAT THAT FOOD OR FOOD PRODUCT IS HALAL OR ANY FOOD OR
- 20 FOOD PRODUCTS TO WHICH SUCH PLUMBA, MARK, STAMP, TAG, BRAND,
- 21 LABEL, OR OTHER MEANS OF IDENTIFICATION HAS BEEN FRAUDULENTLY
- 22 AFFIXED.
- 23 (5) THE DEPARTMENT OF AGRICULTURE SHALL INVESTIGATE AND
- 24 INSPECT THE SALE OF HALAL FOOD PRODUCTS AND SHALL ENFORCE THIS
- 25 ACT. THE DEPARTMENT OF AGRICULTURE MAY PROMULGATE RULES FOR THE
- 26 ENFORCEMENT AND ADMINISTRATION OF THIS SECTION UNDER THE
