THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 18E. (1) THE FAMILY INDEPENDENCE AGENCY SHALL ESTABLISH
- 2 AND ADMINISTER A STATE PLAN FOR FOSTER CARE ACCORDING TO THE PRO-
- 3 VISIONS OF SECTION 477 OF PART E OF TITLE IV OF THE SOCIAL SECUR-
- 4 ITY ACT, 42 U.S.C. 677. THE STATE PLAN SHALL INCLUDE PROGRAMS
- 5 AND SERVICES THAT PROMOTE, IMPLEMENT, AND SUPPORT FOSTER CARE
- 6 YOUTH FOCUS GROUPS TO PROVIDE CONSULTATION AND INPUT INTO FOSTER
- 7 CARE POLICY. PROGRAMS AND SERVICES ESTABLISHED WITHIN THE STATE
- 8 PLAN TO CARRY OUT THE PROVISIONS OF THIS SECTION MAY UTILIZE
- 9 LOCALLY-BASED FOSTER CARE YOUTH FOCUS GROUPS THAT MAY INCLUDE
- YOUTH IN FOSTER CARE, YOUTH PREVIOUSLY IN FOSTER CARE, OR BOTH.

 (2) THE DEPARTMENT OF COMMUNITY HEALTH SHALL PROMULGATE RULES
 PURSUANT TO THE ADMINISTRATIVE PROCEDURES ACT OF 1969. ACT NO. 306 OF THE
 PUBLIC ACTS OF 1969. BEING SECTIONS 24.201 TO 24.328 OF THE MICHIGAN
 COMPILED LAWS. TO IMPLEMENT THE ESTATE RECOVERY PROGRAM REQUIRED BY
 SECTION 1917 OF THE SOCIAL SECURITY ACT. 42 U.S.C. 1396p. THE RULES
 SHALL INCLUDE. AT A MINIMUM. ALL OF THE FOLLOWING:
 - (A) PROCEDURES AND STANDARDS FOR WAIVING RECOVERY BASED ON UNDUE HARDSHIP.
 - (B) PROCEDURES FOR THE ATTACHMENT AND ENFORCEMENT OF LIENS.
 (C) STANDARDS FOR WAIVING RECOVERY BASED ON COST-EFFECTIVENESS.
